INTRODUCTION

STUDYAREA

PROJECT APPLICATION

Enviro Africa has been appointed to conduct the NEMA Application including Environmental Impact Assessment (EIA) for the Lethabo Park Township Establishment Project.

PROJECT DESCRIPTION

Sol Plaatje Local Municipality is in the process of conducting planning and surveying of the informal Township known as Lethabo Park (Ivory Park Extension), located in Roodepan in the north western suburb of Kimberley. The township project has been awarded to a multidisciplinary team led by Macroplan with the aim to provide low and middle-income erven by conducting planning and surveying on the proposed relocation site.

The application will include components of consolidation, subdivision as well as rezoning.

The proposed project entails the development of approximately 2000 low income erven with an average size of 300m²; approximately 100 middle income erven of 500-600m² in size and CRU (Community Residential Units) units (number and size yet to be determined). The total area to be developed measures 90 (ninety) hectares.


