Notice is hereby given of the intention to submit an application for the rectification of the unlawful construction and expansion of the Hantam Veevoere, and the public participation, process in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), and the Section 24G Application in terms of the NEMA EIA Regulations 2014. The proposed development and expansion of the Hantam Veevoere facility includes activities listed in terms of the NEMA EIA Regulations 2014.

EnviroAfrica cc has been appointed by Hantam Veevoere, to undertake the NEMA Application for Environmental Authorisation process.

The activities that have been completed or have commenced (Section 24G Application) will constitute the following listed activities in terms of the NEMA EIA Regulations 2014:

**Project Description & Location:** Hantam Veevoere is an animal feed manufacturer and also provide facilities to house livestock in a concentrated form. Thus animals are raised them until they reach the correct weight for the market. It is proposed that the existing capacity of the sheep feedlot which is 3000 Large Stock Unit (LSU) be expanded by constructing another feedlot with a capacity of 3500LSU. Chicken pens with a capacity to hold 2000 chicks is/will be developed on the even. It is also proposed that there should be pig pens that have been/ will be developed that have the capacity for 100 sows, including holding approximately 50 boars and each sow's piglets.

The existing small scale abattoir on the property is proposed to be expanded for the purpose of slaughtering poultry/livestock. This may be dealt with in a separate application.

This development and expansion of Hantam Veevoere is located adjacent to the R27 on Erf 3000 and Erf 3579, Calvinia, Northern Cape with the following site Co-Ordinates: 31°27'52.99"S, 19°47'31.78"E.
