Notice is hereby given of the intention to submit an application, and the public participation, process in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The proposed 25m high telecommunications mast on the Farm Vaalfontein Wes, Fairhaven, includes activities listed in terms of the NEMA EIA Regulations, 2014.

EnviroAfrica cc has been appointed by Eagle Towers SA (Pty) Ltd, to undertake the NEMA EIA Application for Environmental Authorisation process.

Application for environmental authorization to undertake the following activities:

Project Description & Location:

A telecommunications mast, including associated infrastructure, is proposed on the Farm Vaalfontein Wes, Fairhaven. The proposed development is to clear an area of 64m² to erect a 25m high Monopole mast with antennas situated on the top of the proposed structure. The site is located next to vineyards, and on an existing farm. The site is situated next to Steynsrust Road to the north and Bredell Road to the east. The site co-ordinates are 33° 03' 16.30"S, 18° 48' 21.25"E.

You are also requested to pass this information to any person you feel should be notified.

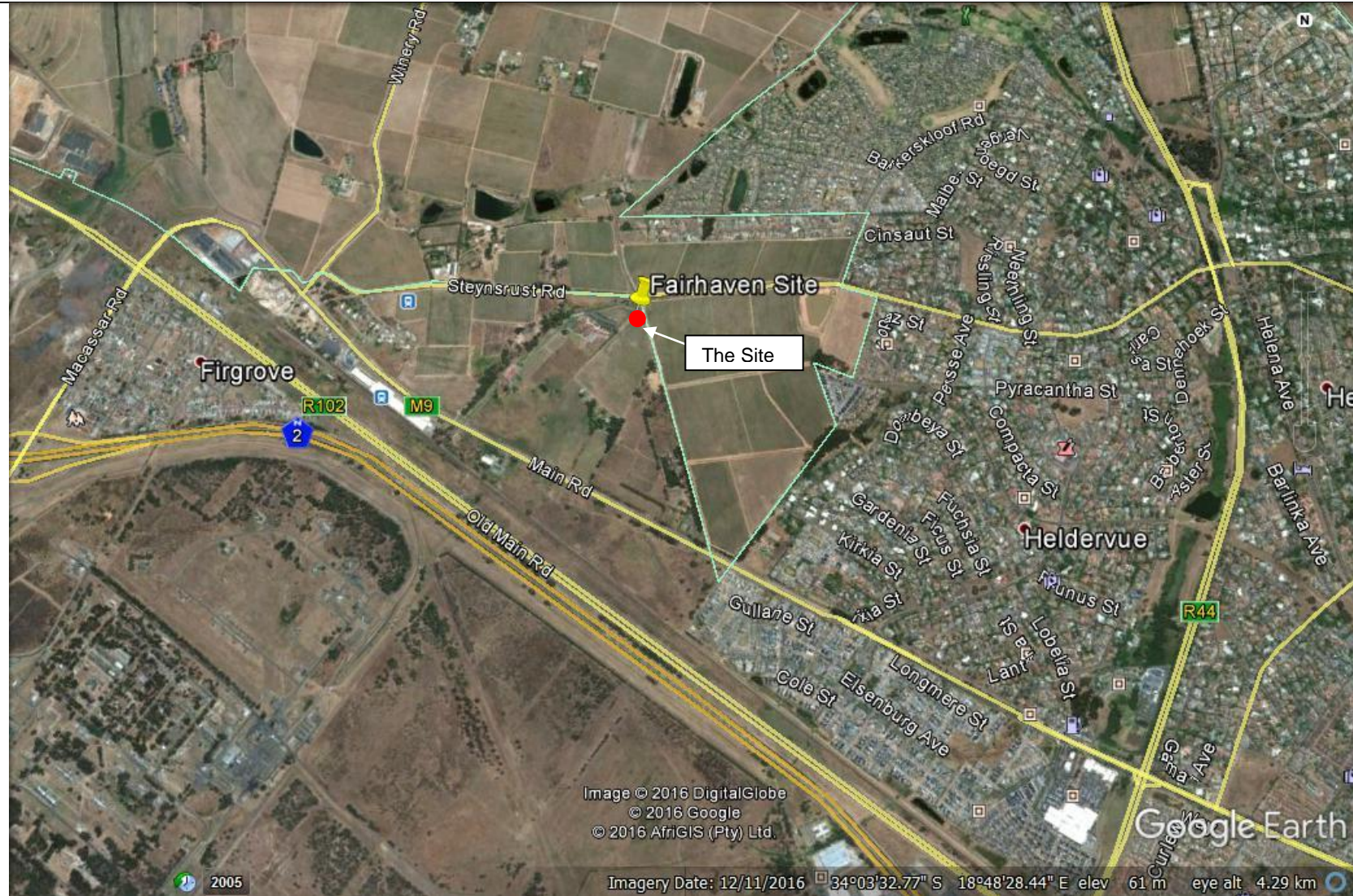
