- In terms of the Swellendam Spatial Development Framework, 2015, the following is of relevance: "With over 90% of water used for irrigation, it would be prudent for specific attention to be given to the continuous improvement of irrigation practices and the maximisation of the benefits derived." (page 28)
- In terms of the Swellendam Integrated Zoning Scheme, 2014, the property is zoned "Agricultural Zone" and the establishment of an irrigation dam is permissible in terms of the zoning.
- Flood mitigation measures need to be considered in the event of a structural failure.
