Heritage Western Cape is in receipt of your application for the above matter received on 31 January 2018. This matter was discussed at the Heritage Officers meeting held on 12 February 2018.

You are hereby notified that, since there is reason to believe that the proposed expansion of the Driefontein Dam in Ceres will impact on heritage resources, HWC requires that a Heritage Impact Assessment that satisfies the provisions of section 38(3) of the NHRA be submitted. This HIA must have specific reference to the following:

- A Paleontological Impact Assessment
- Suggested alternatives to be included

The required HIA must have an integrated set of recommendations.

The comments of relevant registered conservation bodies and the relevant Municipality must be requested and included in the HIA where provided. Proof of these requests must be supplied.

Please note, should you require the HIA to be submitted as a Phased HIA, a written request must be submitted to HWC prior to submission. HWC reserves the right to determine whether a phased HIA is acceptable on a case by case basis.

HWC reserves the right to request additional information as required.
