

**NEMA EIA, PUBLIC PARTICIPATION PROCESS**  
**AFTERFONTEIN BOERDERY: PROPOSED ENLARGEMENT**

**(Portion 33 of the Farm Rietvalley No. 364, Ceres)**

Dear Interested and Affected Parties (I&APs),

Notice is hereby given of a public participation process in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) ("NEMA") and the EIA Regulations (2014) as amended, as well as the National Water Act, 1998 (Act 36 of 1998) ("NWA"); for the application for environmental authorisation (EIA) and a water use licence (WULA) to undertake the following:

EnviroAfrica cc has been appointed by Agterfontein Boerdery, to undertake the Environmental Impact Assessment for the proposed project. A notice of intent to develop was submitted to the Department of Environmental Affairs & Development Planning (DEA&DP).

**Project Description & Location (33° 21' 10.4"S, 19° 24' 14"E)**

It is proposed that the existing Driefontein dam be enlarged as the existing dam does not provide enough storage capacity of the farm for winter listed water. The proposed enlargement of the dam would allow for the storage of summer irrigation water, providing a more efficient use of an already existing water use. With the enlargement of the dam, the dam will have the capacity to store an additional 80 000m<sup>3</sup> water per year. The dam wall will be a maximum of 8,4m with a total surface area of approximately 13 ha.

**Description of Alternatives:**

Alternative includes layout options and the option of not proceeding with the proposed development (the No-Go option) will be discussed in the application process.
