Notice is hereby given of the intention to submit an application, and the public participation, process in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The proposed development of a 30m high telecommunications mast on Portion 108 of Farm Doornrivier No. 369, Aan De Doorns, Western Cape, and includes activities listed in terms of the NEMA EIA Regulations, 2014.

EnviroAfrica cc has been appointed by Eagle Towers SA (Pty) Ltd, to undertake the NEMA EIA Application for Environmental Authorisation process.

Project Description & Location:

A telecommunications mast, including associated infrastructure, is proposed on Portion 108 of Farm Doornrivier No. 369, Aan De Doorns, Western Cape. The proposed development is to clear an area of 59m² to erect a 30m high lattice mast with antennas situated on the top of the proposed structure. The proposed site is Agriculture zoned and is surrounded by agricultural land uses (vineyards). Aan De Doorns Wine Cellar is located on the property. The proposed mast is approximately 320m west of the R43 Road. The site co-ordinates are **33° 41' 49.91" S, 19° 29' 17.53" E**.

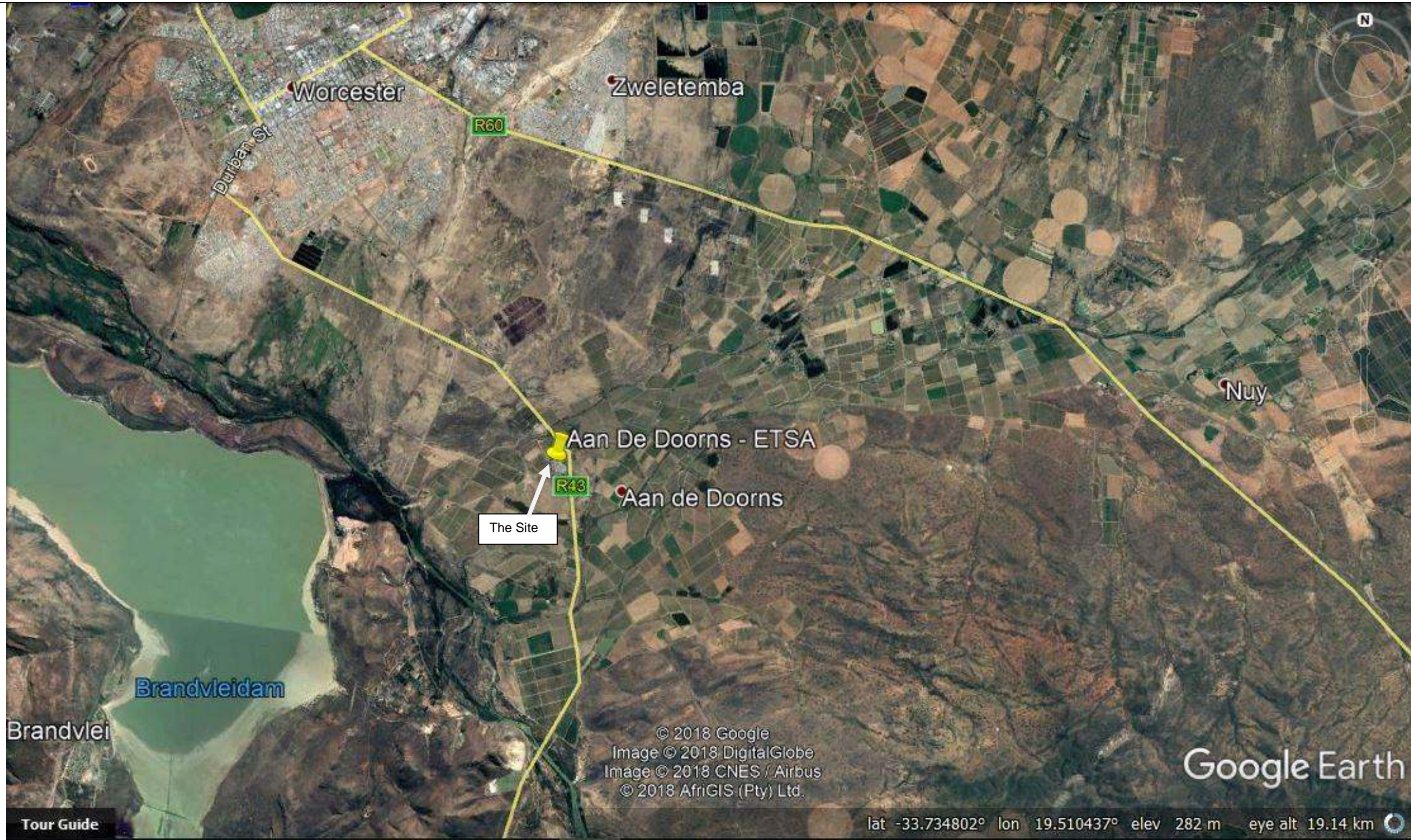
Please note that only Registered I&APs:
