NEMA EIA PUBLIC PARTICIPATION PROCESS

PROPOSED CONSTRUCTION OF A 25M HIGH TELECOMMUNICATION MAST, FARM NO. 778, AVONDROOD, RAWSONVILLE, WESTERN CAPE

Notice is hereby given of the intention to submit an application, and the public participation, process in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The proposed 25m high telecommunications mast on Farm No. 778, Avondrood, Rawsonville, includes activities listed in terms of the NEMA EIA Regulations, 2014.

EnviroAfrica cc has been appointed by Eagle Towers SA (Pty) Ltd, to undertake the NEMA EIA Application for Environmental Authorisation process.

Application for environmental authorization to undertake the following activities:

Government Notice R324 (Listing Notice 3): Activity No. 3

Project Description & Location:

A telecommunications mast, including associated infrastructure, is proposed on Farm No. 778, Avondrood, Rawsonville. The proposed development is to clear an area of 59m² to erect a 25m high Monopole mast with antennas situated on the top of the proposed structure. The proposed site is Agriculture zoned and is surrounded by agricultural land uses (vineyards). The proposed mast is approximately 780m south-east of Louwshoek Voorsorg Road. The site co-ordinates are 33° 43′ 35.22″S, 19° 20′ 16.98″E.
