Please note that our comments only pertain to the biodiversity related impacts and not to the overall desirability of the proposed development. The property on which the development is proposed is classified as No Natural according to the Biodiversity Network for the City of Cape Town and the Western Cape Biodiversity Spatial Plan. The Google Earth imagery indicates that the site is currently cultivated or built upon and does not contain any natural vegetation. No terrestrial ecological specialist studies are considered necessary. There is an artificial farm dam mapped in the south western corner of the property, which would not be considered of biodiversity importance. No other wetlands are mapped for the site. It is not considered necessary to conduct a freshwater specialist study as there are no natural wetlands mapped for the site.
