Notice is hereby given of the intention to submit an application, and the public participation process, in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The unlawful clearance of 40 Ha of vegetation for agricultural development and associated infrastructure on Portions 8 and 9 of the Farm Narries No. 7, Onderstepoort, Kakamas, Northern Cape, includes activities listed in terms of the NEMA EIA Regulations 2014.

EnviroAfrica cc has been appointed by Matlotlo Trading 27 (Pty) Ltd, to undertake the Section 24G Rectification Application for Environmental Authorisation process.

Project Description & Location:

The unlawful clearance of 40 Ha of vegetation for agricultural development and associated infrastructure on Portions 8 and 9 of the Farm Narries No. 7, Onderstepoort, Kakamas, Northern Cape. Augrabies is located approximately 49km south-east of the sites, Kakamas is approximately 75km south-east of the site and the Orange River is approximately 2.6km to the north of the site. The site co-ordinates are 28° 30' 13.06" S, 19° 53' 16.29" E.


