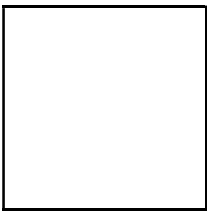
Dear Rene

The proposed 30m high telecommunications mast on Farm 161, Swellendam RD, Buffeljagsrivier, Western Cape, includes activities listed in terms of the NEMA EIA Regulations 2014 (as amended).

EnviroAfrica cc has been appointed by the Atlas Tower (Pty) Ltd, to undertake the NEMA Application for Environmental Authorisation process.

The site is located on Farm 161, Swellendam RD, Buffeljagsrivier, Western Cape,, 34°02'09.18"S 20°32'22.32"E.

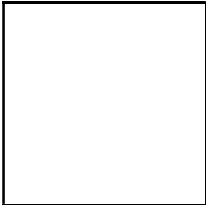
