WAGENBOOMSRIVIER & DARLING BRUG IRRIGATION BOARDS: PROPOSED WATER DISTRIBUTION STRUCTURE AND PIPELINE IN THE SNELRIVIER

Notice is hereby given of a public participation process in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) ("NEMA") and the EIA Regulations (2014) as amended, as well as the National Water Act, 1998 (Act 36 of 1998) ("NWA"); for the application for environmental authorisation (EIA) and a water use licence (WULA) to undertake the following:

Please note that should additional listed activities be identified during the application process they will be communicated to registered I&AP's. EnviroAfrica cc has been appointed by Wagenboomsrivier & Darling Brug Irrigation Boards to undertake the Environmental Impact Assessment for the proposed project. A notice of intent to develop was submitted to the Department of Environmental Affairs & Development Planning (DEA&DP).

Project Description & Location (33° 29' 54.61"S, 19° 16' 47.81"E)

The project involves the investigation of the impact of a distribution structure according to and in line with a Supreme Court Ruling dated 22 February 2017, to distribute water from the Snelriver and stream according to an 80/20 ratio at a designated point. The 80% of the water will be distributed to the Darlingbrug and Wagenboomsrivier Irrigation Boards. The other 20% will be distributed to the other rightful users as per the high court ruling. Currently two strategies are being investigated and are still in concept design phase. The first suggestion is to build an instream structure in the river bed to divide the water 20/80% to the rightful water users. The second option is to build a much smaller structure on the shore of the river to divide the water 20/80% to the rightful water users. From the structure it is suggested that a pipeline be constructed (about 4km) that will be located on existing farm roads which will distribute the divided water to the rightful water users.

Description of Alternatives:


Alternative includes layout options and the option of not proceeding with the proposed development (the No-Go option) will be discussed in the application process.

BASIC ASSESSMENT APPLICATION FOR A WASTE LICENCE & AMENDMENT OF AN ENVIRONMENTAL AUTHORISATION: WASTE-TO-VALUE PLANT, RCL FOODS, MCALISTER STREET, WORCESTER.

The applicant, Trigen Group (Pty) Ltd, is proposing to adapt their effluent-to-biogas Biodigester plant ("waste-to-value plant"), which is situated at the RCL Foods chicken processing plant, Erf 4396, Worcester. It is proposed to adapt the plant to digest animal manure as well as effluent. The adaptation will entail the installation of various associated infrastructure such as additional digester tanks and a manure storage unit.

The purpose of the Biodigester plant is to generate biogas to fuel a Combined Heat and Power Engine, which in turn supplies some of the RCL plant's electricity, process hot water and steam requirements.

The proposed adaptation will increase the electricity supply capacity of the Biodigester plant from the current +/- 1.5MW to up to 10MW.

The plant adaptation will entail energy recovery from general waste (manure); treatment of waste; as well as the construction of facilities for waste management.

These waste management activities require the application for a Waste Licence through a Basic Assessment-type application process. This is in terms of the requirements of the National Environmental Management Act (NEMA); and the NEM Waste Act. An amendment of the current Environmental Authorisation for the effluent Biodigester is also required in terms of the NEMA to authorise the proposed changes to the plant.
