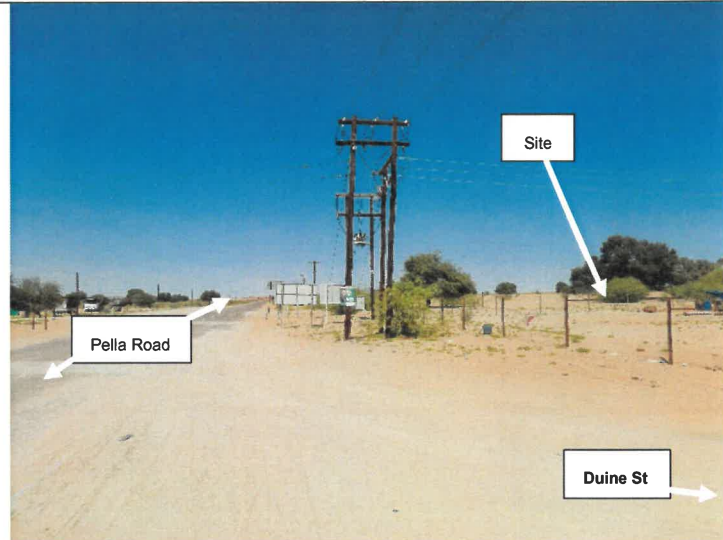


Figure 4: A2 Poster placed against the fence on site as viewed from the corner of Pella Road and Duine Street, looking in a southern direction. Informal structures can be seen on site.

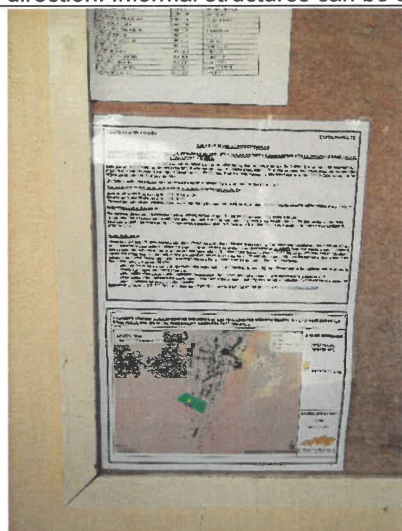


Figure 9: A3 Poster placed against notice board at Khai-Ma Municipality in Pella.

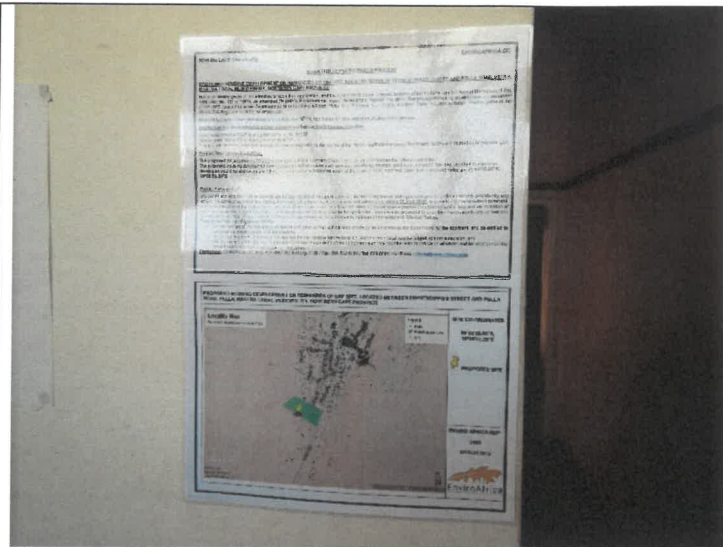


Figure 18: Maildrops done along Kerk Street.

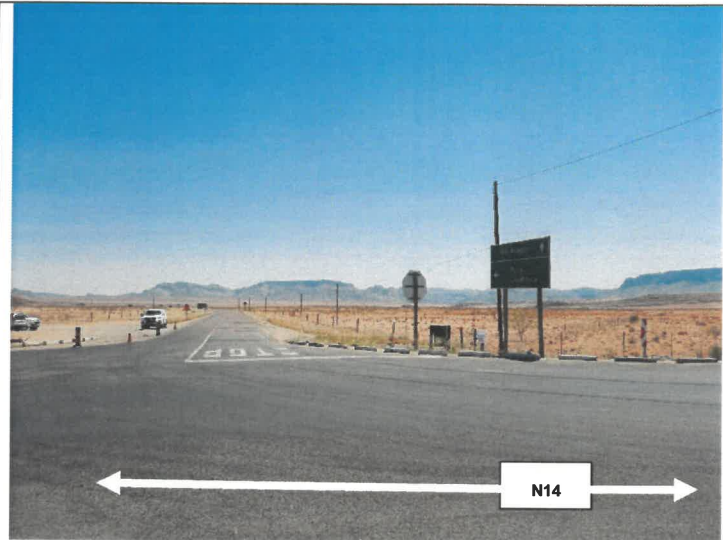


Figure 24: A2 Poster placed against fence along intersection of N14 and Pella Road. Looking north, towards Pella Road.
