Pre-Application Basic Assessment Report for the Proposed New Public Cemetery and Memorial Park on the Remainder of Farm Louw's Bos 502, Jamestown, Stellenbosch (DEA&DP ref. no. 16/3/3/6/7/1/B4/45/1288/17)

CapeNature would like to thank you for the opportunity to comment on the proposed development and would like to make the following comments. Please note that our comments only pertain to the biodiversity related impacts and not to the overall desirability of the proposed development.

For the Background Information Document (BID) for this application, only the alternative north of Annandale Road (Louw's Bos North) was put forward for consideration, whereas an alternative footprint south of Annandale Road (Louw's Bos South) has been included as an additional alternative for the Pre-Application Basic Assessment Report (BAR), both located on the same large municipal cadastre.

The Louw's Bos South proposed footprint consists of No Natural across its full extent according to the Western Cape Biodiversity Spatial Plan (WCBSP) and no freshwater features are mapped within the footprint. As stated in the BID, Louw's Bos North is classified as Critical Biodiversity Area (CBA) 2 in in the far eastern section, with patches of CBA 1 and Ecological Support Area (ESA) 2, although the majority of the property is classified as No Natural. There is a watercourse mapped in the centre of the site with associated ESA 2 and a small wetland in north according to the WCBSP. The vegetation type that would have occurred across both alternative sites is Swartland Granite Renosterveld, listed as Critically Endangered.

A botanical constraints analysis has been undertaken for Louw's Bos South which provides a detailed description of the vegetation across the site and is described as secondary vegetation that has established on the site after lying fallow following ceasing of cultivation. The species present are weedy, pioneer species and the vegetation cannot be considered as representative of Swartland Granite Renosterveld.

Google Earth imagery further confirms the description provided in the botanical constraints analysis with clear evidence of cultivation across the entire site within the past 10 years with the eastern section still actively cultivated.

The conclusion of the botanical constraints analysis was that the vegetation on site is not of conservation value and therefore there are no constraints to development. CapeNature agrees with the findings of the botanical constraints analysis.

Louw's Bos North was not included in the botanical constraints analysis however it was part of the site screening which informed the BID. While a large proportion of this area did not present constraints from a terrestrial biodiversity perspective, there were patches of natural vegetation that needed to be avoided. Our comments on the BID should be referred to for more detail.

A preliminary freshwater assessment was undertaken for both Louw's Bos North and Louw's Bos South. The wetland delineation verified the presence of the wetland mapped on the WCBSP in the central section of Louw's Bos North, which is classified as an unchannelled valley bottom wetland, with another unchannelled valley bottom wetland in the south eastern corner and a channelled valley bottom wetland in the south western corner. For Louw's Bos South, there is a channelled valley bottom wetland that encroaches slightly on to the site in the north eastern corner with artificial farm dams surrounding the property. The recommendation is that the wetlands and a 15 m buffer should be implemented as constraints for the proposed cemetery and memorial park.

The proposed preferred alternative for the development is Louw's Bos South and a layout plan has only been compiled for this alternative. The layout design is currently only conceptual, however it does appear that the proposed development does avoid the wetland and the 15 m buffer, which only encroaches slightly on to the site, however this must be confirmed.

As biodiversity constraints have been taken into consideration we do not have any objection to the preferred development alternative and do not have further comments on the layout itself. We do however wish to propose that the density of burials are maximised as far as possible due to the high demand for land for alternative land uses in addition to the existing demand for cemetery space, as is motivated for in this application.

In conclusion, CapeNature does not object to the preferred development alternative. While both Louw's Bos North and Louw's Bos South do present opportunities for the proposed development, we agree that the preferred alternative will not have any impacts on biodiversity as the site is transformed and will not impact on any natural freshwater features. The environmental management plan (EMP) must however be strictly implemented and we recommend that more detailed controls and measures are required for the operational phase.

Noise Pollution - Funerals are held on weekends, often with large crowds of mourners attending, making use of megaphones, which may be classified as a nuisance. Will noise pollution and the management thereof be addressed in the assessment?

Our initial feedback and objections around the proposed and alternate sites.

1. Whilst we understand that the Municipality is under pressure to extend their public cemeteries footprint, we would like to see the research and proposals that have gone into addressing this in the longer term.

Cities around the world are facing the same crisis of space, yet they are exploring alternates which don't require the use of more land space – i.e. grave recycling in Europe and green burials.

The cemetery draft feasibility study on the record was published 13 years ago and is an insufficient basis on which to explore future options.

1. The proposed land in the preferred site is zoned agriculture and the loss of this agricultural land is detrimental to the region. In the motivation report on record, the selection criteria for a site, indicated an erf of 30ha as the required space and this proposal is for 74 ha?

This loss of agricultural land could have significant impacts on job creation and food security for the region should this not be utilised for its original zoning as productive agriculture. The Competing Use Impact assessment would be significantly in favour of Agriculture for this identified area.

- 1. Whilst the proposal talks to biodiversity conservation areas within the development footprint, there are other environmental considerations and concerns:
- \* Soil and Ground Water Contamination as a result of the burial practices- Coffins, embalming and decomposition of the bodies. These physical, chemical and micro-biological contaminations all present threats to the ground water and soils both in the area and surrounding farms.
- \* The Fresh Water and Geo-Hydrological Assessment has identified and delineated the water courses, groundwater and potential impacts, however there is no mention of the impacts of the activities in the post-construction phase as mentioned in point 3a above.

#### 1. Traffic impact assessments:

As indicated in your own Road Access Report a full TIA is required to understand the potential impacts on the area. A criterion for consideration of site selection talks to public accessibility and this area has limited public transport available.

1. Visual and Heritage Impact: With the current roadworks on Annandale road hindering a more comprehensive report of the visual impacts on heritage farmlands, this aspect is of major concern especially when coupled with considerations around security, lighting and buildings required.

We trust that these comments will be well considered during this approval process and opportunities for feedback and engagement on alternatives considered.



ENVIRONMENTAL IMPACT ASSESMENT PRE-APPLICATION PUBLIC PARTICIPATION PROCESS FOR THE PROPOSED NEW PUBLIC CEMETARY AND MEMORIAL PARK ON REMAINDER OF FARM LOUW'S BOS NO.502 STELLENBOSCH MUNICIPALITY.

We would like to object to the proposed new public cemetery and memorial park on Remainder of Farm Louw's Bos No.502, Stellenbosch Municipality based on the following:

#### 1. Rezoning from Agricultural:

The area ear-marked for rezoning is agricultural.

There are many areas in closer proximity to Stellenbosch or on the surrounding borders thereof which would be better suited for the exact purpose the Municipality is applying for. The reasoning behind the rezoning for this proposal appears to be an economic one as the Stellenbosch Municipality owns the land in question and would thus not have to spend its funds acquiring land for the same purpose closer to or in a residential area.

The proposed land in the preferred site is zoned agriculture and the loss of this agricultural land is detrimental to the region. In the motivation report on record, the selection criteria for a site, indicated an erf of 30ha as the required space and this proposal is for 74 ha?

This loss of agricultural land could have significant impacts on job creation and food security for the region should this not be utilised for its original zoning as productive agriculture.

It is felt that the establishment of a cemetery and memorial park will set a dangerous precedent for future applications and developments in the immediate vicinity of the Lynedoch and greater Stellenbosch region where agriculture is the predominant activity.

#### 2. Traffic:

To date no traffic study or estimated traffic flow studies have been made available or completed to establish how the road, its surface and other vehicles and residents would be impacted. There is also insufficient public transport facilities in the immediate area of the proposed cemetery and memorial park.

A full traffic impact assessment will thus be required.

#### 3. Heritage:

The Stellenbosch region is well known for agriculture and as a source of superior local produce for our national retailer network. This has contributed to food security and is a significant source of employment in the Western Cape.

It must be noted that agricultural land that is developed (for whatever purpose) can NEVER again be used for agriculture. In a country where food security and lack of suitable agricultural land is a reality, it would not be wise to allow agricultural land to be used for any other purpose other than agriculture.

It is also concerning that municipal land (irrespective of its intended use) and being situated so close to a critically important water source (i.e. Eerste River) can be utilised for non-farming activities and specifically as a cemetery given that it will never be able to be relocated in the future.

The additional impacts on Heritage include the following which will need to be fully assessed:

- 1. Security for the Cemetery / Memorial Park
- 2. Parking
- 3. Ablution Facilities
- 4. Community Hall / Place of Worship
- 5. Visual Impact

#### 4. Groundwater Contamination:

A wide range of literature exists of the effects of cemeteries and decomposing bodies on ground water. The research points to potential disastrous consequences should ground water become contaminated. The cemetery management and municipality also have no control over how human remains are preserved and what chemicals are used and will be used in the future. It is too dangerous and the consequences too great to place a cemetery in the centre of prime agricultural ground.



Should any contamination be found that is traced to the proposed cemetary, it would have dire consequence for the environment and the agricultural economy of Stellenbosch not to mention the farmers on the Annandale Road that supply their products into retail markets both locally and abroad. The Annandale Road supplies close to 50% of the country's Strawberries spread throughout the Annandale Road corridor.

#### 5. Water Use:

It must be noted that the subject property does have existing water rights granted to it by the Department of Water Affairs. This begs the question why land with existing water rights is proposed when so much other municipal land has no water rights at all.

This allocation (4ha) cannot be transferred to neighbouring farmers and will permanently be lost should the proposed cemetery proceed. The loss of such an allocation will impact on the expansion plans of farmers in the immediate vicinity of the proposed cemetery as there may not be sufficient water allocation in the area when required.

Given the recent drought the Western Cape has recently endured and continues to experience, it would be severely detrimental to the region to lose water rights when they are available to use and when the land in question is situated so close to a critically important water source (i.e. Eerste River).

It should also be noted that a dam was constructed on the proposed land and has previously been in use for agricultural purposes and would be available in the future were farming operations to recommence on the property.

We also need to understand whether any boreholes exist on the subject property and whether any geotechnical or hydro census testing has been performed as yet to determine whether the area is suitable for further development.

#### 6. Reduction in Property Values:

It is felt that should the proposed cemetery proceed, that it would reduce the values of surrounding properties as the land in question does not suite the surrounding areas' business environment (i.e. farming).

## 7. Other Environmental Concerns

The proposed cemetery covers a large area of the subject property and due to the nature of cemeteries, ground is typically not covered with vegetation to prevent dust.

This results in large plooms of dust affecting the entire area and crops being cultivated.



We trust that the above comments will be considered and that the proposed cemetery and memorial park be relocated elsewhere in order to allow for the fand in question to be utilised for its primary purpose of agriculture.

With specific reference to issues raised by FSM, please note:

- i. of the approximately 74ha proposed for the total Louw's Bos development, the actual cemetery footprint is around 34,53ha and of this only about 19.97ha are allocated for traditional grayes/interment with 14.56ha being used for alternate/more modern burial trends. It should also be noted that there is only one site proposed for the northern region of the Municipality i.e. Calcutta which, due to various constraints, has an actual cemetery footprint of around 19ha - the Louw's Bos development is proposed for the southern region of the Municipal district.
- ii. an agricultural soil assessment for the preferred site was undertaken as appended to the DBAR.
- iii. a traffic impact assessment was undertaken as appended to the DBAR.
- iv. as stated in the pre-application and DBAR, access for all proposed development alternatives is from Annandale road.
- the scope of this proposed development did not include crematoria and the associated legislated air V. pollution/air quality related issues. Whilst cremation is standard practice amongst Hindus and common amongst Christians/Western culture, it is forbidden by Muslims and Orthodox Jews. Several African cultures traditionally view cremation as undesirable (although not prohibited). This memorial park concept is also an attempt at educating and appealing to communities regarding the various alternate burial and remembrance options available such (other than traditional graves).
- vi. a socio-economic assessment (including need and desirability) of the proposed development, is appended to the DBAR.
- vii. the review and possible amendment to local by-law/s is also mentioned in the DBAR since this may be required to accommodate multiple interments in a single burial space, after sufficient time has lapsed between each interment.
- viii. It is intended that proposed idea "to bury the ashes of a loved one at the foot of a tree" be used to promote alternative burial methods. The idea is that once the initial purchase of e.g. a 'family tree' is made, subsequent burial of ashes of loved ones will be in small, dedicated 'shafts' (just large enough for typical ash boxes or bio-degradable urns) at specific points around the tree, so as not to affect tree growth/health. This also allows multiple burials of ashes at one point/in one shaft with a plaque.
- ix. While Louw's Bos North has not been excluded from the proposed development alternatives in the DBAR since it is one of the two sites the Applicant has available in the southern region of the Municipality, it is definitely <u>not</u> the preferred alternative.

Pre-Application Basic Assessment Report of January 2019 Public Cemetery and Memorial Park, Louw's Bos Farm No. 502

26 February 2019

#### 1. Urban Structure and Land Use

- 1.1 The search for land suitable for future burial space is, of course, understood. The present PBAR has pro forma addressed many aspects of the relevant environmental and other impacts. The footprint of the proposed Louws Bos site is, however, more than 70 hectares, not taking into account the other Calcutta and De Novo sites or future expansion. This footprint is very large compared to comparable land use units in rural areas.
- 1.2 Furthermore, the conversion into a cemetery and memorial park would insert a clearly non-rural land use into a rural area in which land use is focused on agriculture.
- 1.3 Some background: The Stellenbosch IDP as well as the Spatial Development Framework are clear on the principle of densification and Transit-Oriented Development, whereby urban development should be concentrated within the urban edge and urban sprawl becomes unacceptable.
- 1.4 The large size of the proposed cemetery and memorial park and new land use implies that the proposed development has not only local environmental impacts but land use impacts. The BAR and any future studies must therefore include a proper land use study which explicitly considers the spatial development context of the region, including the land-use criteria of compactness and accessibility set out in the MSDF and elsewhere.
- 1.5 Of course a "cemetery and memorial park" is not urban housing development. Nevertheless, there is a clear need to consider the size of the footprint of any non-rural land use in a rural environment. Specifically: If the same number of graves and burial sites can be accommodated on an alternative with a smaller footprint, that alternative needs to be assessed fully. See also the comments on layout below.

1.6 Likewise, **agricultural land** is scarce countrywide, and high-quality and even medium-quality land must, by government policy, be conserved. That requirement holds even if land currently lies fallow. The BAR should therefore also include a proper assessment of agricultural soil potential.

#### 2. Roads and Traffic

- 2.1 Closely related to land use issues is the matter of roads and traffic. Within the parameters of the IDP, MSDF and the Comprehensive Integrated Transport Plan (CITP), human mobility should move away from unsustainable private car use mode to public transport and non-motorised transport. This, too, points to the advantages of a more compact layout and smaller footprint.
- 2.2 Clearly the BAR cannot be complete without a proper Traffic Impact Assessment. The Western Bypass has been shown not to be feasible from the viewpoints of cost, traffic modelling and conformance with transport legislation, and must be ignored within the BAR. The **traffic impact assessment** may not rely on its construction in doing any modelling.
- 2.3 For the same reason, the possibility of a Western Bypass bisecting the Louw's Bos North terrain must be discounted. If at all, access from Annandale Road is clearly the only option.

#### 3. Cremation, layout and costs

- 3.1 The BAR for the present Louw's Bos as well as the parallel Calcutta and De Novo assessments have entirely neglected the issue of cremation. While the older generation may prefer burial in graves, the increasing shortage of agricultural land, the low density of land use and the long-term costs of maintaining large sites all imply that the future of burial lies with crematoria, not with large cemeteries and memorial sites. Mere reference to present cultural preferences does not thereby settle the matter.
- 3.2 Crematoria can easily be linked to memorial functions by means of more compact memorial wall and memorial park site layouts in which urns and plaques be housed.
- 3.3 The BAR must therefore consider an alternative (at Louw's Bos or elsewhere) which posits the development of a more compact crematorium plus urn-centered memorial park.
- 3.4 The large footprint of a conventional cemetery and Memorial Park also imply higher operating costs. These higher operating costs will have to be recovered either from the municipal budget or from burial site fees. High fees would imply an impermissible barrier to burial for the poor. The BAR should include a section comparing the overall economic feasibility of the conventional grave and memorial park alternative to a more compact alternative.
- 3.5 While the idea of "burying the ashes of a loved one at the foot of a tree" may seem at first sight a nice one, it would also imply either reserving one tree per ashes-burial and thereby a **very** low density of sites, or it would imply multiple burials at the foot of the same tree, which would imply multiple root disturbances and the resulting negative impact on the development of the tree itself. It is romantic but neither economically or horticulturally feasible.

#### 4. Biodiversity and water

4.1 Water: The creation of a large-footprint memorial park is problematic from a water use point of view. The critical and worsening water shortage in the Western Cape is well

- known. It is not feasible or scientifically defensible to rely on borehole water for watering many hectares or ornamental gardens under prevailing and worsening water restrictions and drought.
- 4.2 The botanical assessments both of McDonald and Botes indicate a low sensitivity for the Louw's Bos South part of the site. We agree with that assessment. However, there is also general agreement that the western part of the Louw's Bos North site contains both CBAs and ESAs. "Incorporation" into a Memorial Park is not feasible as renosterveld and conventional compost- and fertiliser-based are not compatible.
- 4.3 We also note that the CBAs on Louw's Bos North are adjacent to the very important large CBA on portion 10 of Farm 502 (immediately west of the airfield) and should continue to form part of that complex.
- 4.4 It is well known that the duration of flowering of fynbos and renosterveld species can be as short as two weeks. A proper botanical assessment of the CBAs therefore cannot rely on a single site visit but must include multiple site visits over a number of months in spring and summer.
- 4.5 The awkward geometry of the Louw's Bos North site also precludes its suitability for inclusion in the cemetery-memorial park layout. We recommend that Louw's Bos North be excluded from the proposal.
- 5. Different sites: This pre-application BAR (PBAR) requests comments while in parallel other processes are being conducted for Calcutta and De Novo. While the mechanisms of assessment must run their separate course, an informed assessment must pertain to all sites simultaneously. We note that Rumball (in his undated document appearing in Appendix M) ranked the sites in order of desirability as
  - (a) Calcutta,
  - (b) De Novo.
  - (c) Louw's Bos,
  - (d) Meerlust, and
  - (e) Keyersdrift.
- 6. Technical Matters: The Draft Basic Assessment Report published under the file name 0-Pre-Application-BAR-with-cover-page,pdf is in a scanned PDF format which precludes electronic searching. It would be appropriate to provide the original PDF rather than a scanned version.

Only 13% of South Africa's land is suitable for agricultural farming. The agricultural sector in the Western Cape makes a significant contribution to the Western Cape economy. The land that has been identified for the cemetery expansion is currently a vineyard.

Wine estates and wine farming are not only important economically through wine production and sales, but the tourism that is attracted to Stellenbosch and environs is largely centred around our wine estates.

Horizontal expansion of cemeteries in and around Stellenbosch is a threat to our agricultural sector and sustainable development in Stellenbosch and surroundings.

Like elsewhere in the world, Stellenbosch, which aspires to be an innovation centre in South Africa, has to adopt forward thinking solutions to how to accommodate the demand for burial places.

In Japan, for example, a 100% cremation rate was reached many years ago. China is now trying hard to emulate Japan's example by expropriating coffins and burning them for fuel. Purely on economic grounds, taking valuable, irreplaceable agricultural land for this purpose is short sighted. Our community will have to adapt and follow practices elsewhere in the world, which has been through our current development curve - cremation and family mausoleums, i.a., must be considered for the future. If the demand for graves is unavoidable, land not suitable for agricultural use should be identified and zoned for this purpose.

The Stellenbosch Ratepayers' Association (SRA) realises that this is a very sensitive issue but we need to address this issue sooner rather than later.

It would accordingly be appreciated if you could stress the "no go" option as the preferred alternative in this assessment process.

Currently Jamestown and Groendal cemeteries are reaching maximum capacity, whilst Wemmershoek and Franschhoek South and North are fully operational. Pniel and Onder Papegaaiberg Cemeteries are full to capacity (with only reserved graves being available at Onder Papegaaiberg).

According to the town planners, the proposed Louw's Bos public cemetery and memorial park will consist of approximately 74ha. The actual area proposed to be utilised for cemetery purposes totals to approximately 34.53ha.

The general formula for calculating traditional grave (i.e. interment) space, as set out by the Western Cape Department of Environmental Affairs and Development Planning (DEA&DP), is determined at 2000 graves per hectare or alternatively 5m² per traditional grave, including 10% for circulation.



In the proposed Louw's Bos public cemetery and memorial park, of the approximately 34.53ha dedicated to cemetery space, approximately 19.97ha is proposed for use as traditional grave space. Using the formula provided by DEA&DP, 39 940 traditional graves may be provided for as set out below.

1. 19.97 ha x 2000 = 39 940 graves

39 940/810 = 49 years

2.  $199700 / 5m^2 = 39940$  graves

Calculating at an average of 810 deaths per annum (latest available statistics), 4050m² grave space per annum will be required. Therefore, over the next 30 years, about 12.15ha of land will be required. The proposed regional site should provide sufficient traditional interment space for approximately the next 49 years.

Note: An increase and decrease in mortality rates can have an impact on the life span of the cemetery.

It is proposed that the remaining 14.56ha be used for more modern trends in burial methods and will include memorial walls, lawn graves, the use of trees as headstones and memorial plaques. The number of possible burials to be accommodated within the remaining approximate14.56ha, is undetermined.

# **OUR REFERENCE: LIMBERLOST PROPERTY HOLDINGS (PTY) LIMITED (468/102)**

We would like to object to the proposed new public cemetery and memorial park on Remainder of Farm Louw's Bos No.502, Stellenbosch Municipality based on the following:

# 1. Rezoning from Agricultural:

The area ear-marked for rezoning is agricultural.

There are many areas in closer proximity to Stellenbosch or on the surrounding borders thereof which would be better suited for the exact purpose the Municipality is applying for. The reasoning behind the rezoning for this proposal appears to be an economic one as the Stellenbosch Municipality owns the land in question and would thus not have to spend its funds acquiring land for the same purpose closer to or in a residential area.

It is felt that the establishment of a cemetery and memorial park will set a dangerous precedent for future applications and developments in the immediate vicinity of the Lynedoch and greater Stellenbosch region where agriculture is the predominant activity.

Our company employs in excess of 600 employees from the region and has had discussions with the Stellenbosch Municipality to lease the land in question for agricultural purposes and thereby create in excess of 500 direct employment opportunities as well as contribute to the upliftment of the Lynedoch community.

# 2. Traffic:

The proposed site for the cemetery and memorial park would be on the Annandale Road which connects the R44 to the R310. This road is comprised of a single lane from either side and predominantly services the farms / residents thereon.

The farms in question are primarily grape / strawberry producers which utilise a large fleet of tractors and large trucks (i.e. inter-links) for transport into their properties.

It is felt that the additional use of the Annandale Road by mourners and visitors as well as funeral processions entering or leaving the proposed cemetery would not only disrupt the traffic flow but also impact on road safety.

In addition to the above, it should be noted that there is no street lighting on the Annandale Road which will further impact on road safety for visitors to the cemetery in the evenings or in times of poor visibility as companies in the Lynedoch area make use of transporters (i.e. inter-links) on a 24hour basis during season - not to mention the various tractors / trucks transporting staff and product during the year.

Further to this, cars travelling in an easterly direction on the Annandale Road would completely obstruct traffic as there is no "Turn Right" lane. This would cause major backlogs in traffic.

To date no traffic study or estimated traffic flow studies have been made available or completed to establish how the road, its surface and other vehicles and residents would be impacted.

## 3. Heritage:

The Stellenbosch region is well known for agriculture and as a source of superior local produce for our national retailer network. This has contributed to food security and is a significant source of employment in the Western Cape.

It must be noted that agricultural land that is developed (for whatever purpose) can NEVER again be used for agriculture. In a country where food security and lack of suitable agricultural land is a reality, it would not be wise to allow agricultural land to be used for any other purpose other than agriculture.

It is also concerning that municipal land (irrespective of its intended use) and being situated so close to a critically important water source (i.e. Eerste River) can be utilised for non-farming activities and specifically as a cemetery given that it will never be able to be relocated in the future.



The additional impacts on Heritage include the following:

# a.) Security for the Cemetery / Memorial Park:

The proposed cemetery will likely require a fence as well as security office / access boom for security purposes.

The fence and / or security office will, irrespective of its size and type, not conform with the surrounding heritage of the area being of an agricultural nature.

# b.) Parking:

The proposed cemetery will require sufficient parking area for mourners and visitors.

The parking area will, irrespective of its size and type, not conform with the surrounding heritage of the area being of an agricultural nature.

# c.) Ablution Facilities:

The proposed cemetery will require ablution facilities for mourners and visitors.

These facilities will, irrespective of its size and type, not conform with the surrounding heritage of the area being of an agricultural nature.

# d.) Community Hall / Place of Worship:

The proposed cemetery may require a community hall or place of worship for mourners and visitors.

This area will, irrespective of its size and type, not conform with the surrounding heritage of the area being of an agricultural nature.

#### e.) Visual Impact:

The visual impact of the items listed above cannot be under estimated in terms of the Heritage assessment when assessing the suitability of the subject property to be utilised as a cemetery / memorial park.

The proposed cemetery is expected to border the Annandale Road thereby impairing the natural landscape of agricultural land surrounding it and specifically zoned for that purpose.

# 4. Groundwater Contamination:

A wide range of literature exists of the effects of cemeteries and decomposing bodies on ground water. The research points to potential disastrous consequences should ground water become contaminated. The cemetery management and municipality also have no control over how human remains are preserved and what chemicals are used and will be used in the future. It is



too dangerous and the consequences too great to place a cemetery in the centre of prime agricultural ground.

Should any contamination be found that is traced to the proposed cemetary, it would have dire consequence for the environment and the agricultural economy of Stellenbosch not to mention the farmers on the Annandale Road that supply their products into retail markets both locally and abroad. The Annandale Road supplies close to 50% of the country's Strawberries spread throughout the Annandale Road corridor.

# 5. Water Use:

It must be noted that the subject property does have existing water rights granted to it by the Department of Water Affairs. This begs the question why land with existing water rights is proposed when so much other municipal land has no water rights at all.

This allocation (4ha) cannot be transferred to neighbouring farmers and will permanently be lost should the proposed cemetery proceed. The loss of such an allocation will impact on the expansion plans of farmers in the immediate vicinity of the proposed cemetery as there may not be sufficient water allocation in the area when required.

Given the recent drought the Western Cape has recently endured and continues to experience, it would be severely detrimental to the region to lose water rights when they are available to use and when the land in question is situated so close to a critically important water source (i.e. Eerste River).

It should also be noted that a dam was constructed on the proposed land and has previously been in use for agricultural purposes and would be available in the future were farming operations to recommence on the property.

We also need to understand whether any boreholes exist on the subject property and whether any geotechnical or hydro census testing has been performed as yet to determine whether the area is suitable for further development.

# 6. Reduction in Property Values:

It is felt that should the proposed cemetery proceed, that it would reduce the values of surrounding properties as the land in question does not suite the surrounding areas' business environment (i.e. farming).

Many of the farmers in the area make use of external / debt financing which could be severely curtailed should land values decrease going forward as these values are often pledge for security when required.



If access to capital and / or debt is reduced, it would have a direct impact on expansion opportunities and employment going forward.

# 7. Other Environmental Concerns

The proposed cemetery covers a large area of the subject property and due to the nature of cemeteries, ground is typically not covered with vegetation to prevent dust.

This results in large plooms of dust affecting the entire area and crops being cultivated.

We trust that the above comments will be considered and that the proposed cemetery and memorial park be relocated elsewhere in order to allow for the land in question to be utilised for its primary purpose of agriculture.

- 3. Departmental comments on the pre-application draft BAR:
  - 3.1 Various activities have been included that may potentially be triggered. Confirmation of the applicable activities must be included in the in-process draft BAR.
  - 3.2 Coordinates on Page 34 must be amended to reflect the Louws Bos site, currently the coordinates are for the Calcutta site.
  - 3.3 If groundwater is to be abstracted, then proof that a Water Use License Authorisation ("WULA") in terms of the National Water Act, 1998 (Act 38 of 1998) was submitted to the Department of Water and Sanitation must be provided.
  - 3.4 The following issues with respect to the draft Environmental Management Programme ("EMPr") must be addressed:

- 3.4.1 Reference is made to Bonnievale Renosterveld Thicket and the Botanical Assessment (Appendix 12) in various sections. The incorrect reference of the vegetation type in the EMPr must be amended to reflect the correct information.
- 3.4.2 It is noted that the site is heavily infested with alien invasive plants, however, the EMPr does not include any aspect regarding alien vegetation removal/management for the site.
- 3.4.3 The operational phase of the EMPr must be updated to include management activities and mitigation for all activities. This section incorrectly refers to Property Owners Association in terms of management during the operational phase.
- 3.4.4 A storm water management plan for the site must be included.
- 3.4.5 If applicable, a maintenance management plan for the structure/s crossing the watercourse must be included.
- 3.4.6 In addition to the abovementioned issues, the EMPr does not fulfil the requirements of Appendix 4 of the EIA Regulations 2014 (as amended) and must be corrected.

# 4. Regulatory Requirements:

- 4.1 Proof of placing an advertisement in a local newspaper and erecting site notices must be provided.
- 4.2 Proof of the notifications sent to registered I&APs for the commenting purposes must be included in the final BAR.





#### Dear D'Mitri

Thank you for the opportunity afforded us during the pre-application meeting mentioned above. Herewith, a summary of the information discussed at the meeting:

# **Background**

The initial Notice of Intent (NOI) submitted in 2017 for the Proposed Louw's Bos Public Cemetery and Memorial Park Development (Ref. No.: 16/3/3/6/7/1/B4/45/1289/17) indicated that there were no alternative sites available for the development, as was the case at the time. A high-level pre-application round of public participation was conducted purely to register interested and affected parties (I&APs). This first round of public participation was for 60 days due to the water use licence application requirements which were triggered. Several comments and queries were received.

Subsequently, in May 2018, the applicant (Stellenbosch Municipality) indicated that an additional site in the south of the district was now available for the proposed development. Thus, alternative sites became available. This site, whilst on the same farm i.e. Louw's Bos RE 502, is located on a completely different part/erven of the farm when compared to the original proposed Louw's Bos development site. A second NOI was therefore recently submitted for the Proposed Louw's Bos South Public Cemetery and Memorial Park Development (Ref. No.: 16/3/3/6/7/1/B4/45/1341/18), to confirm if the two sites could be combined into one impact assessment process and to clarify the way forward, even though an initial round of PPPP had been conducted.

# Way forward

As per the Department's instructions:

- A full round of public participation must be conducted as a <u>revised</u> pre-application public participation process (PPPP) with both sites clearly indicated on the posters and maildrops (this will enable one reference number to be allocated to the case)
- ii. A draft basic assessment report (DBAR) with all specialists' report input must be circulated as part of this revised PPPP
- iii. Specialists' used to assess the first Louw's Bos site must be used for the new/alternative Louw's Bos South site as well to enable comparative assessments
- iv. Subsequent to the freshwater specialist's assessment of the Louw's Bos South site, the period of the revised PPPP must be confirmed with the Department of Water and Sanitation i.e. whether the revised process must run for 30 days or 60 days
- v. Should a period of only 30 days be required for the revised PPPP, cognisance must be taken of the December 2018 'builder's break' in determining the minimum 30 days allowed for comment

#### **Additional matters**

The Department further instructed the Applicant and EnviroAfrica that a written request to close the file on the 2017 NOI submitted for a separate application, Meerlust Public Cemetery and Memorial Park Development (Ref. No.: 16/3/3/6/7/1/B4/45/1292/17), be submitted to the case officer since it was indicated that this NOI would not be pursued further at this stage. Should the applicant require that the site be revisited in the future, a new NOI/process should then be initiated.

It was also confirmed that the Calcutta Public Cemetery and Memorial Park Development (Ref. No.: 16/3/3/6/7/1/B4/45/1288/17) could undergo a second round PPPP with the DBAR issued for comment, provided all the specialist reports were available for inclusion and taking cognisance of point 'iv & v' above.

However, during 2018, another site on the farm became available to the Applicant, thereby providing a preferred alternative location for the above proposed development.

# **Preferred Site Location and Description**

The proposed development site is located on remainder of Farm Louw's Bos No. 502, immediately south, off Annandale Road. Access to the proposed development will be from Annandale Road. The proposed development footprint will occupy approximately 74ha of the total property and lies approximately between the Eskom substation to the east and high voltage power line to the west. It is proposed that the development be a cemetery and memorial park, promoting the establishment of biodiversity conservation areas within the development footprint. Proposed associated infrastructure includes access roads leading to and within the site, entrance wall and perimeter fencing, parking, a memorial wall, ablutions, stormwater management infrastructure.

#### **Description of Alternatives:**

Besides the option of not proceeding with the proposed development at all (the No-Go alternative), only one other alternative to the preferred development site, exists. This alternative site lies to the north-east of the preferred site, on the opposite side of Annandale Road across the Bonte River. Alternative options will be considered within the draft basic assessment report and associated documents which will be available from the 25<sup>th</sup> January 2019 on EnviroAfrica's website at www.enviroafrica.co.za (under Projects/For Public Participation/Louw's Bos Public Cemetery and Memorial Park).




