Notice is hereby given of a public participation process in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) (“NEMA”) and the EIA Regulations (2014 as amended), as well as the National Water Act, 1998 (Act 36 of 1998) (“NWA”); for the application for environmental authorisation (EIA) and a water use licence (WULA) for the proposed construction of two new dams on the Farm Houdenbek 415 (Toeka dam and Harmony Dam)

The two dams are:

1. The Harmony Dam will approximately 250 000 cubic metres (5ha in size)
2. The Toeka dam will be approximately 250 – 350 Million cubic metres (approximately 35 ha in size).

These dams will belong to Harmony Trust (BEE initiative) with the purpose of assisting the Trust in establishing an economical farming unit (please read underneath).
