Water quality will be minimally, insignificantly impacted. The theory has it that runoff from pristine mountain catchment dilutes polluted runoff from agricultural areas. However, the volume from the Harmony stream is so small in relation to that of the Houdenbeks River that it would not make a noticeable difference. The cumulative effect of many such small dams may have an impact, but since we do not have any numbers from analytical laboratory analyses, this is all speculation.

Another dam would add to ground water. Instead of running away, water would sink into the ground under the dam. This is a small dam and the gain would be small as well.

The dam would alter aquatic habitat , as all new dams do. If moved downstream, the loss of valuable riparian vegetation would be minimised.

The dam can be constructed with a release valve to make provision for ecological releases. But yes, the many dams and water use in the upper catchment have a significant impact of the Doring River downstream. The hydroperiod has been shortened and this river is dry for much longer than it was prior to human impact. Water can be taken during peak flow, as is stated in the Fresh Water Report, and left during base flow and low flow, to reduce the impact on hydroperiod.




