Hi Inge - please find attached quote. For this one HWC will definitely expect an archaeologist to have walked every square inch given the sensitivity of the rock art in the area.



However, the good news is that the dams do not fall on areas of Table Mountain sandstone and I doubt Jonathan will find any rock art sites. He certainly won't find any rock art on the Toeka Dam. There's a small section in the southeast corner of the Harmony Dam that may have something though (rock art).. unlikely but possible.

We'll absorb the costs of the HIA for this one as both Jonathan and John are going to expect 1 day each of report writing income. I just don't think it is fair to charge for 3 days of report writing on such a limited impact project and we'll therefore restrict our income to the screener for this one.
