


Figure 5: A view of the proposed site, looking in a north-western direction towards Ertjiesvlei hall and Hemel en Aarde Road. An old toile located approximately 10m south of the site. The site is completely transformed with no natural vegetation present.




Figure 10: A view of the access road and access gate as viewed from the south-eastern corner of the property. Looking towards Ertjiesvlei hall and Hemel en Aarde Road, looking in a in a north-western direction.




Figure 13: A view of the proposed site (red arrow), looking in a northern direction towards Ertjiesvlei hall and Hemel en Aarde Road.




Figure 14: A view of the proposed site (red arrow), looking in a northern direction towards Ertjiesvlei hall on the property.




Figure 17: A view of the proposed site access road, looking in a north-western direction towards Hemel en Aarde Road.
