The Directorate: Pollution & Chemicals & Chemicals Management (D: PCM) hereby acknowledges receipt of the above-mentioned application on 29 August 2019 and has the following comment:

1. Sanitation

- a. The site layout plan 1 (Appendix B1) shows various ablution (toilet) facilities located throughout the site. It is not clear from the layout plan or the DBAR if all ablution facilities will be connected to a common septic tank. This must be clarified in the next phase of the BAR.
- b. The position of the septic tank/s must be updated/displayed on the preferred site layout plan in appendix B1.
- c. In the event that the municipality cannot service the septic tanks (due to municipal strikes or tanker trucks broken down etc.) the applicant must devise a contingency plan for the alternate safe pumping of the septic tank/s. This contingency plan must be included in the operational phase of the EMP.
- d. Written confirmation must be sought from the Engineering and Technical Services Department of the Stellenbosch Municipality, advising that adequate capacity exists at the Stellenbosch Waste Water Treatment Works to accept the sewage load (via tanker trucks) from the proposed development.

2. Geotechnical Study

a. It is recommended that no traditional burials take place in the vicinity of trial pit 8, which had groundwater seepage at 1.5m, in order to reduce the risk of pathogenic contamination of groundwater resources.





For your records, please see below the notes I made during the Louw's Bos meeting with DWS.

- 1. Vivienne & Chris assured that the irrigation reservoir/feature will be removed from the design layout, and the BAR will be updated accordingly.
- 2. DWS advised against an open detention pond from which watering would take place, and instead recommended that an enclosed tank is used from which irrigation may then take place.
- 3. DWS recommended that the sewage package plant and irrigation take place outside 500m from the watercourses in order for it to be a GA. If the plant and watering were to take place within 500m then a WULA may be required; but they may consider a GA nonetheless.
- 4. For ease, from an application point of view, it would be better to apply for a borehole separate from the existing water use allocation that the farm portion has been assigned as a change of land use for the irrigation water requires a WULA, while a new application shouldn't given the scale and nature of the use.
- 5. Client is to provide a revised layout (if the client agrees) and information regarding the volume and specifications of the sewage package plant.
- 6. Enviroswift will be required to re-look at the risk assessment based on the new information.

- 2.2. During the construction phase, any solid waste should be appropriately stored at the Facility, until such time that it can be disposed of at a licensed facility, suitable of accepting such waste.
- 2.3. Should more than 100m³ of general waste, or more than 80m³ of hazardous waste be stored at the Facility, for a period exceeding 90 days, the Facility will need to register in terms of, and adhere to the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) "National Norms and Standards for the Storage of Waste", as contained in Government Notice (GN) No. 926 of 29 November 2013.
- 2.4. Kindly note that all fuels should be stored in a bunded area, capable of holding 110% of the total volume of fuel stored.
- 2.5. Should there be any spills of hazardous substances at the Facility, which could lead to environmental degradation, the management of such spills should adhere to section 30 of the National Environmental Management Act, 1998 (Act 107 of 1998), as amended, which includes reporting responsibilities.

Please be advised that all comments submitted during pre-application and application phases must be included and responded to in the final BAR. In addition, all issues raised that require amendments to the BAR must be addressed.
 - 3.2 Appendices B1 and B2 both refer to the layouts as being the preferred layout. These pages must be amended to reflect which layout is preferred or not preferred.
 - 3.3 The coordinates on Page 13 differs from those on Page 37. Only the correct coordinates must be included in the final BAR.

- 3.4 The Environmental Management Programme ("EMPr") must include recommendations that will be implemented for the development e.g. 15m for the wetland in the north eastern corner of the site.
- 3.5 Section E of the BAR, with respect to the Site Alternatives must be amended to included reasons why the various alternatives assessed are preferred or not preferred.
- 3.6 Comment from the Department of Agriculture must be obtained with respect to the proposed development.
- 3.7 Comment from the Department of Water and Sanitation has not been included in the draft BAR. Furthermore, there is no proof of the submission of a Water Use License Authorisation ("WULA") in terms of the National Water Act, 1998 (Act 38 of 1998). Proof of submission to the Department of Water and Sanitation must be included in the final BAR.
- 3.8 It is noted that there is no comment from this Department's Directorates Waste and Pollution Management included in the draft BAR. Please be advised that comment from the aforementioned Directorates must be included in the final BAR.

CapeNature would like to thank you for the opportunity to comment on the proposed development and would like to make the following comments. Please note that our comments only pertain to the biodiversity related impacts and not to the overall desirability of the proposed development.

CapeNature commented on the background information document and Pre-Application Basic Assessment Report (BAR) in which we indicated that there were no terrestrial biodiversity constraints and that we do not object provided the wetland and buffer in the north-east corner of the site are not impacted upon.

The proposed development layout provided for the Pre-Application BAR was broad and conceptual, which has now been refined significantly and allows for accurate interrogation of the potential impacts. The freshwater assessment has been updated and has been used to inform the two development layout alternatives. The preferred layout has changed the access road to entering the property from the centre, whereas the non-preferred layout has the access road entering the property in the north eastern corner.

CapeNature agrees with the selection of the preferred layout as this avoids any impact on the wetland and buffer in the north eastern corner by the access road. In conclusion, CapeNature therefore does not object to the development proposal as indicated in the preferred layout, provided that the Environmental Management Plan is implemented.

COMMENTS ON DRAFT BAR FOR THE PROPOSED LOUW'S BOS PUBLIC CEMETERY & MEMORIAL PARK ON LOUW'S BOS, RE/502, STELLENBOSCH MUNICIPALITY

Applicability of the Western Cape Land Use Planning Act, 2014

- The proposed development will have a significant impact on agriculture and the heritage of the area, in particular not only is the proposed development a significant size, but it would appear that in all likelihood, should it be approved, it will be further significantly expanded in the future.
- 2. It is noted that under the heading "Site Description" on page 12 of the draft BAR that the proposed site is approximately 487ha in extent, and that the total development footprint will be approximately 74ha. Considering that:
 - 2.1. the development footprint is more than 5 ha;
 - 2.2. from the information contained in the draft BAR at page 53 in particular, it is clear that "the bulk of the land" has been cultivated or irrigated in the last 10 years; and
 - 2.3. the proposed development cannot be regarded as an agricultural land use or land development ordinarily associated with agricultural use;

an approval in terms of section 53 of the Western Cape Land Use Planning Act, 2014 is required.

Visual impact

3. Page 16 of the draft Basic Assessment Report (BAR) states the following:

"This is the greatest likely heritage related impact is (sic) on the visual environment since it is rural and partially scenic along this route. "The proposed development will have a high visual impact on the landscape (both sites) causing noticeable (South site) to some (North site) change to the visual environment. The proposed development has moderate (North site) to high (South Site) visual exposure, moderate (both sites) visual absorption capacity, medium (both sites) compatibility, and is moderately (North site) to highly visible (South site) along Annandale Road".

(Own emphasis)

- 4. But at page 29 of the draft BAR the above is contradicted where it states "the proposed development will have a <u>moderate impact</u> on the landscape <u>causing some change to the visual environment"</u>. This is misleading and the effect thereof is that interested and affected parties (IAPs) are unable to make meaningful comments on the visual impacts of the proposed development.
- 5. In addition, at page 29 is stated "the development's visual impact has site-related to local extent, long term duration, medium intensity, definite probability, and medium significance on the landscape". This statement is non-sensical and therefore impossible to comment on.
- 6. At page 53 of the draft BAR it is stated that "the impact oncultural/heritage aspects will be positive". This contradicts the findings of the draft BAR as set out in paragraphs 3 and 4 above.
- 7. At page 57 of the draft BAR it is stated that "the design of both layout alternatives on the preferred site, Louw's Bos South, avoids potential visual impacts...". This contradicts the findings of the draft BAR as set out in paragraphs 3 and 4 above.
- 8. At page 48 of the draft BAR it states that "[a]Ithough a Heritage Screener as prepared by CTS Heritage (Appendix G8) for the Louw's Bos North site (but



including the Louw's Bos South site as part of the general surrounds) was submitted to HWC prior to this application process".

9. Considering that:

- 9.1. the South site is the preferred alternative;
- 9.2. the preferred alternative will have a greater visual impact than that of the proposed alternative (the so-called "North site")
- 9.3. the proposed development "will have a high visual impact on the landscape (both sites) causing noticeable (South site)" change to the visual environment":
- 9.4. the visual impact is "the greatest likely heritage related impact; and
- 9.5. that the "Heritage Screener" contained in Appendix G8 was undertaken primarily for the North site; and that the recommendation of the Heritage Screener was that "the proposed development is likely to impact on heritage resources and as such, it is recommended that a complete Heritage Impact Assessment is required that assesses impacts to landscape character and archaeological resources";

a Heritage Screener should have been done for the preferred alternative and a further, visual impact assessment should also be undertaken for the preferred alternative.

10. No Heritage Impact Assessment (HIA) was provided for the IAPs to comment on. It (Appendix G7) is not located on the EnviroAfrica website as per the letter to the IAPs. The public participation process is therefore fatally flawed and should be redone so that the IAPs can comment on the HIA in the context of the rest of the draft BAR and appendices.

Impact on Groundwater

11.At page 53 of the draft BAR it is stated that "[t]here may be a negative impact on groundwater resources". And at page 54 of the draft Bar it is stated that "[n]egative impacts include the potential risk of leachate from the cemetery. However, the



geohydrological, geotechnical and freshwater assessments indicate that the probability of this occurring is low".

12. Even though impact on groundwater is stated to be low, the possibility of the agricultural operations of the groundwater users in the area being affected is of huge concern, particularly due to the possible potential impact on the grapes.

Incomplete/nonsensical responses in the BAR relating to the "No-Go" option

13. At page 57 of the draft BAR it is stated that the impact of the "No-Go" option is that "[t] Municipality will face a crisis situation in terms of burial ground availability since the interim relief measure of expanding certain cemeteries (which were able to expand), will also rapidly be diminished". With respect, this is not a valid response to the question of "Details of the identified and considered alternatives". The response should relate to the impacts of the "No-Go" option on the preferred sites and not the impacts on the Municipality.

Conditions and mitigation measures for the proposed development

14. At page 78 of the draft BAR it is stated that conditions/mitigation measures will "be provided in FBAR". This is unacceptable as the IAPs have had no opportunity to comment on any proposed conditions or mitigation measures if they are of the view that such conditions or mitigation measures are insufficient, ineffective, inappropriate, unenforceable or will not adequately mitigate the impacts of the proposed development.

I spoke at some length to Vivienne Thomson this morning because I could not find reference to the attached letter in Appendix F of the DBAR below. Some 35 ha of the 75 ha farm will be set aside but only 19,5 ha would be used for burial purposes with the remainder forming a memorial park in an attempt to encourage the community to move away from burials.

The other site "Culcutta Bos" is situated on the R304 near Koelenhof. These two sites if approved should serve Stellenbosch for the next 50 years.
