CapeNature would like to thank you for the opportunity to comment on the proposed development and would like to make the following comments. Please note that our comments only pertain to the biodiversity related impacts and not to the overall desirability of the proposed development.

The property on which the development is proposed is classified as No Natural according to the Biodiversity Network for the City of Cape Town and the Western Cape Biodiversity Spatial Plan. The Google Earth imagery indicates that the site is within an urban area and the natural vegetation has been lost. No terrestrial ecological specialist studies are considered necessary, however further verification is required that no natural vegetation will be affected.

The Kromboom Canal is located on the western side of the M5, however based on the locality map the mast is proposed on the eastern side. It is not considered necessary to conduct a freshwater specialist study, provided that further verification is given that no wetlands will be affected.

CapeNature will comment in more detail on the Draft Basic Assessment Report, however we are unlikely to object to this application.
