ACKNOWLEDGEMENT OF RECEIPT OF THE REQUEST FOR EXTENSION IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO. 107 OF 1998) ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS (GN NO. R. 982 OF 4 DECEMBER 2014) FOR THE PROPOSED DEVELOPMENT OF A 25 METRE HIGH TELECOMMUNICATIONS TREE MAST ON PORTION 112 OF THE FARM HANS MOES KRAAL NO. 202, GEORGE

- The letter from your appointed Environmental Assessment Practitioner ("EAP"), EnviroAfrica cc, regarding the request for extension of the lapsing period, received on 12 December 2019, refers.
- 2. This letter serves as acknowledgement of receipt of the request by this Department.
- 3. This Department notes your request to extend the lapsing period contemplated in terms of Regulation 3(7) of the Government Notice ("GN") No. R.982 of 4 December 2014 (as amended).
- 4. Please be reminded that the date for submission of the final Basic Assessment Report ("BAR") was 7 January 2020. However, after considering the motivation, this Department hereby grants your request in accordance with Regulation 3(7) and it is agreed that the prescribed timeframe be extended as set out below:
 - The final Basic Assessment Report must be submitted to this Department by no later Monday, 9 March 2020.
- 5. In light of the EAP's motivation and accordance with the provisions of the Environmental Impact Assessment Regulations, 2014, your EAP must:

5.1. Amend the Revised Draft Basic Assessment Report (dated November 2019) to address the scope of work and identified outstanding information.

The EAP must ensure that all the shortcomings highlighted in this Directorate's letter, dated 11 December 2019, are addressed in the amended report (i.e. Second Revised Basic Assessment Report).

5.2. Subject the amended report to a public participation process of at least 30-days within the extended period.

In this regard, all the registered interested and affected parties (including organs of state which have jurisdiction in respect of any aspect of the relevant activity and the competent authority) must be notified of the availability of the amended report and be provided an opportunity to comment, in writing, on the reports or plans submitted during the public participation process.

- 6. In the event that the Basic Assessment Report is not received within the specified timeframe, the application will lapse in terms of Regulation 45 of GN No. R.982 of 4 December 2014 (as amended) and the file will be closed. Should you wish to pursue the proposed development, a new application process will have to be initiated and a new application for environmental authorisation submitted to Department for consideration. Please note that should an application fee be applicable, this must be paid again prior to submission of the application for environmental authorisation.
- 7. Please note that **one** printed copy as well as one electronic copy (saved on CD/DVD) of the Second Revised Basic Assessment Report <u>must</u> be submitted to the Department.
- 8. Kindly quote the above-mentioned reference number in any future correspondence in respect of the application.
- 9. Please note that the activity may not commence prior to an Environmental Authorisation being granted by the Department. It is an offence in terms of Section 49A of the NEMA for a person to commence with a listed activity unless the Department has granted an environmental authorisation for the undertaking of the activity. Failure to comply with the requirements of Section 24F and 49A of the NEMA will result in the matter being referred to the Environmental Compliance and Enforcement Directorate of this Department for prosecution.
- 10. This Department reserves the right to revise or withdraw initial comments or request further information from you based on any information received.

It is unclear whether a hard copy of the RBAR was made available to all registered interested and affected parties ("I&APs"). Is it therefore reasonable to expect that registed I&APs did not have an opportunity to review the impoact assessment. Please refere to commpent below regarding public participation."

<u>I sincerely apologise for this ommission</u> and in line with point 2.5 of the Department's comment i.e.

"Public Participation

Please be reminded that all registered interested and affected parties (including organs of state and the competent authority) are entitled to comment, in writing, on all reports or plans submitted during the public aprticiation process. Any public participation process must be conducted for a period of at least 30 days.

Should any information have been ommitted from any of the documents, reports or plans during the public participation process, this may prejudice the outcome fo the application.

Your EAP is advised to address this matter before proceeding with the application."

To correct this error, EnviroAfrica on behalf of the Applicant, will undertake an additional public participation process ensuring that all registered I&APs have the opportunity to comment in writing, on Appendix J2 (Impact Assessment Ratings) of the RBAR.


