On 24 March 2020, I was contacted telephonically by Ms. Thembi Nyoka from the national Department of Agriculture, Forestry and Fisheries (DAFF) who requested that I send you the application forms for the four separate applications (reference number below) on the farm Visserspan Farm No. 40, near Dealesville, Free State Province. The farm falls within REDZ 5. The four projects are:

Visserspan Solar PV Facility - Project 1 (Ref. No. 14/12/16/3/3/1/2153);
Visserspan Solar PV Facility - Project 2 (Ref. No. 14/12/16/3/3/1/2154);
Visserspan Solar PV Facility - Project 3 (Ref. No. 14/12/16/3/3/1/2155);
