Many thanks for your letter.

I have registered Gariep Watch as an Interested and Affected Party, and as such you will be notified of our environmental reports when they are available for viewing for further comment.

Your comments and concerns have been noted. A freshwater specialist has been appointed, and has conducted initial site visits. Their freshwater impact assessment will form part of our environmental impact reports.

Bvi Engineers have been appointed to address the services for the proposed development, which will include sewage infrastructure. The engineering services reports are not complete as yet. Details of the sewage infrastructure will need to be addressed and will be included in our environmental impact reports.
