Thanks for your response and contribution to the success of the project. Yes we are happy to reach completion stage. We managed the environmental part of the project very well, the ECO visited the site regularly, did inspections and reported back to the project team. I can also confirm that the contractor, Asla Construction, also contributed by complying to the environmental rules and standards, there was no serious incidents reported and the site was always neat and tidy.

During the project the client made additional money available and we removed some of the alien *Prosopis glandulosa* trees stream-up and down-stream from the bridge in- and next to the river course.
