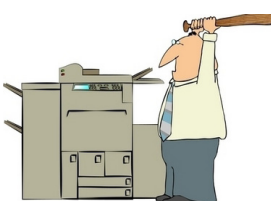

PROPOSED DEVELOPMENT OF A 55M HIGH TELECOMMUNICATION MAST ON REMAINDER OF FARM NO. 146, MIDDELWATER FARM, HANOVER, NORTHERN CAPE

Notice is hereby given of the intention to submit an application, and the public participation process, in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The proposed 55m high telecommunication mast on Remainder of Farm No. 146, Middelwater Farm, Hanover, Northern Cape, includes activities listed in terms of the NEMA EIA Regulations 2014.

EnviroAfrica cc has been appointed by the Atlas Tower (Pty) Ltd., to undertake the NEMA Application for Environmental Authorisation process.

**Project Description & Location:**

A telecommunications mast and base station is proposed on Remainder of Farm No. 146, Middelwater Farm, Hanover, Northern Cape. The base station will have a developmental footprint of less than 300m<sup>2</sup> and will include a 55m high lattice mast with antennas situated on the top of the proposed structure, and four service provider equipment containers. The site will be enclosed with a 2.4m high palisade fence for safety and security reasons. The site is located off the N10 road and is situated on a koppie. An existing farm road will be used to gain access to the foot of the koppie and a 3m wide access road will be developed to access the site. The site co-ordinates are: 31°15' 21.02"S, 24°45' 4.49"E.
