

A telecommunications mast and base station is proposed on Remainder of Farm No. 146, Middel-water Farm, Hanover, Northern Cape. The base station will have a developmental footprint of less than 300m² and will include a 55m high lattice mast with antennas situated on the top of the proposed structure, and four service provider equipment containers. The site will be enclosed with a 2.4m high palisade fence for safety and security reasons. The site is located off the N10 road and is situated on a koppie. An existing farm road will be used to gain access to the foot of the koppie and a 3m wide access road will be developed to access the site. The site co-ordinates are: 31°15' 21.02"S. 24°45'4.49"E.
