Thank you for your response regarding the SSV report for the proposed expansion of the Zwartfontein Dam (Ref: 16/3/3/1/F5/16/2002/21).

Below, please find responses to the Directorate's comments:

2.2.1. Noted. Impacts relating to the lost of agricultural land will be included in the Final BAR. It has also been noted that an Agricultural Compliance Statement will not be required.

2.2.2. It is noted that the Directorate agrees with the Low Sensitivity rating for the Animal Species Theme. Measures to mitigate any potential impacts will be provided in the Final BAR and EMPr.

2.2.3. It is noted that the Protocols regarding the Aquatic Biodiversity Theme have been complied with.

2.2.4. It is noted that the Directorate agrees with the Low Sensitivity for the Civil Aviation Theme and that no further requirements are applicable.

2.2.5. It is noted that the Directorate agrees with the Low Sensitivity for the Defence Theme and that no further requirements are applicable.
