Notice is hereby given of the submission of the Draft Basic Assessment Report (DBAR), and the public participation process ("PPP"), in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment ("EIA") Regulations, 2014 (as amended) for the **Proposed Expansion of an Instream Dam on the Remainder Of Farm Zwartfontein No. 792 And Portion 8 of the Farm Zwartfontein No. 792, Zwartfontein, Malmesbury, Western Cape**. EnviroAfrica cc has been appointed by the Black Orchid Farming (Pty) to undertake the NEMA Application for the Environmental Authorisation process.
