

Basics key to being safe

With learners gradually returning to school it is important to keep them and all staff members safe from the coronavirus.

Emma Corder, managing director of Industroclean, said the essential first step is to stick to the basics.

“This being hand hygiene, correct mask usage, respiratory etiquette and physical distancing.”

She advised on creating a “Covid-19 Back to School Pack”. The use of a big sized pencil box is perfect to pack two clean masks, a pack of wet wipes and hand sanitizer.

Learners must take their own water bottles so as to not fill them at school or use public water taps, and especially to not drink directly from the mouthpiece of a tap.

She said the three best cleaning practices (at school and at home) are:

- Prepare for cleaning and disinfecting. Use all chemicals correctly and make sure cleaning equipment are clean, for example mop sleeves must be soaked in cleaning solution before being used.
- Do the job. Clean or wipe from the top to the bottom, from clean to dirty.
- At the end of the task, dispose of dirty water and waste according to safety procedures. Wash and dry all equipment before storing it in a clean space and dispose of all personal protective equipment in the right manner before washing up.
