






## MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY

#### MAP OF RELATIVE ANIMAL SPECIES THEME SENSITIVITY




## MAP OF RELATIVE AQUATIC BIODIVERSITY THEME SENSITIVITY


## MAP OF RELATIVE ARCHAEOLOGICAL AND CULTURAL HERITAGE THEME SENSITIVITY


#### MAP OF RELATIVE CIVIL AVIATION THEME SENSITIVITY


#### MAP OF RELATIVE DEFENCE THEME SENSITIVITY


#### MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY
