Certificate to Commence Business Explanation:

The Applicant is the Witvlei Boerdery Trust (IT452/1994). Please refer to full Deed of Trust uploaded in online/SAMRAD application.

Mr C A Bruwer, is the appointed representative of the Witvlei Boerdery Trust (IT452/1994) in this mining permit application.

Mr C A Bruwer is also the owner of C A Bruwer Konstuksie CC (please refer to Company Registration Certificate), an established construction, earth moving, transportation and associated activities business in the Kakamas region since 2012. The company lists its primary activities as mining, earth moving, transport and associated activities.

This mining permit application is for a less than 5ha cumulative mining and processing plant area for the surface excavation of feldspar (and minerals associated with the presence of feldspar/resulting from the excavation of feldspar) to a depth of not more than to 18-20m on a privately owned farm, Portion 5 of Rozyne Bosch Farm Number 104, Kakamas South, Kai!Garib Local Municipality, Z F Mgcawu District Municipality.

The feldspar ore (together with minerals associated with the presence of feldspar/resulting from the excavation of feldspar) will only be excavated from the proposed site, before being transported to the processing plant site which is also located on Rozyne Bosch Farm No. 104/5. At this plant, the ore will be crushed and loaded directly into 5 ton trucks for transportation by C A Bruwer Konstuksie CC to the respective clients' premises to whom it has been sold.
