CORRECTION TO THE ENVIRONMENTAL AUTHORISATION ISSUED ON 05 NOVEMBER 2020: FOR THE DEVELOPMENT OF THE 100MW VISSERSPAN SOLAR PHOTOVOLTAIC FACILITY PROJECT 1 ON VISSERSPAN FARM NO. 40, NEAR DEALESVILLE, TOKOLOGO LOCAL MUNICIPALITY, FREE STATE PROVINCE

The Environmental Authorisation (EA) issued for the abovementioned application by this Department on 05 November 2020, as amended and the correction letter received by the Department on 06 August 2021, refer.

In terms of the National Environmental Management Act, 107 of 1998, as amended, and the NEMA EIA Regulations 2014, as amended, the Department herewith makes the following correction to the Environmental Authorisation issued on 05 November 2020 (Ref: 14/12/16/3/3/1/2153), as follows:

Inclusion of Listing Notice 1, Activity 28 to the EA:

Residential, mixed, retail, commercial, industrial or institutional developments where such land was used for agriculture, game farming, equestrian purposes or afforestation on or after 01 April 1998 and where such development:

- (i) will occur inside an urban area, where the total land to be developed is bigger than 5 hectares; or
- (ii) will occur outside an urban area, where the total land to be developed is bigger than 1 hectare; excluding where such land has already been developed for residential, mixed, retail, commercial, industrial or institutional purposes.'

This letter must be read in conjunction with the EA dated 05 November 2020, as amended and the conditions of this EA remain valid and in force.
