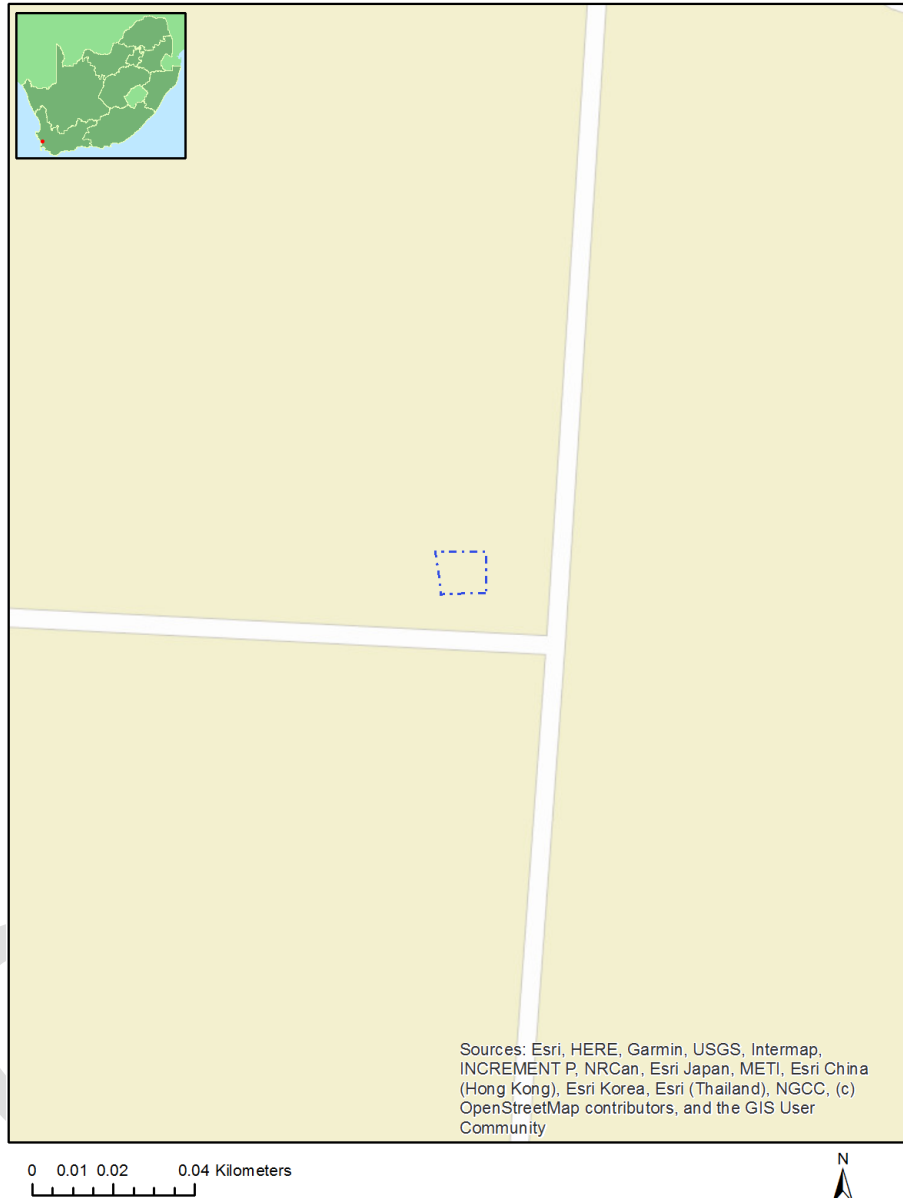

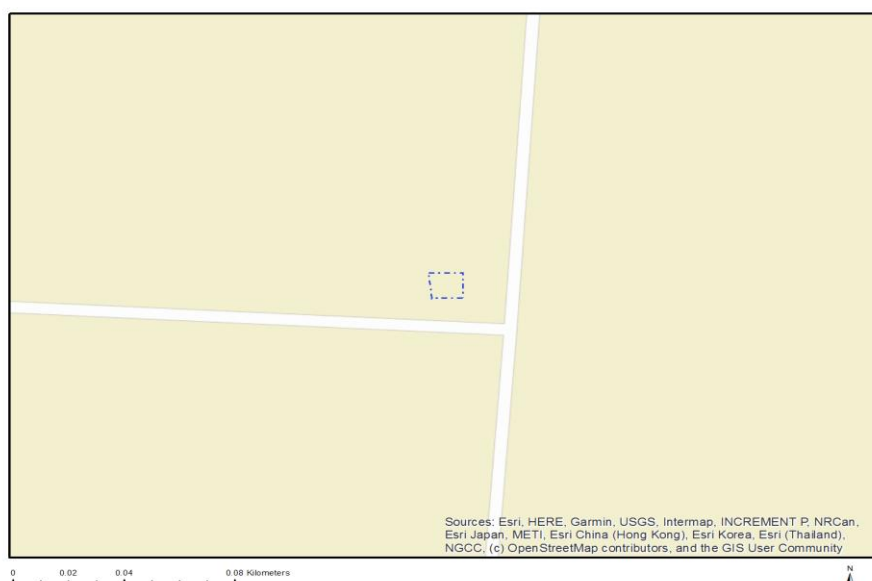

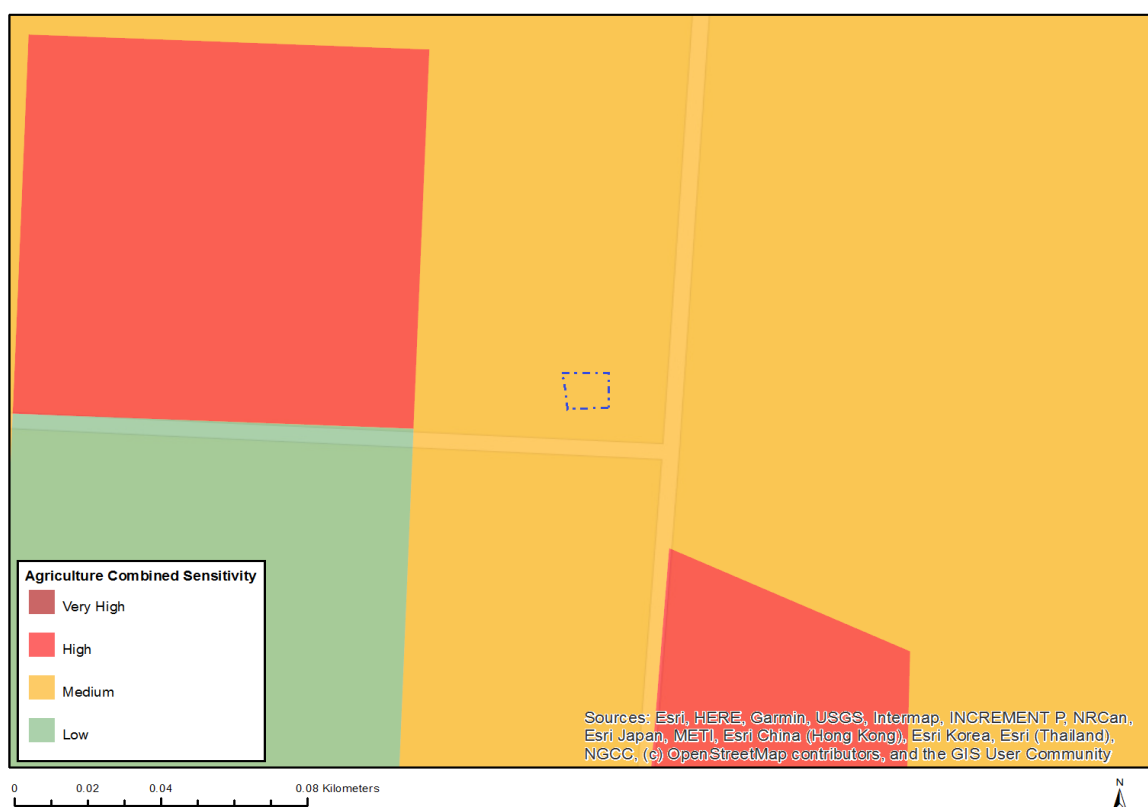

MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY

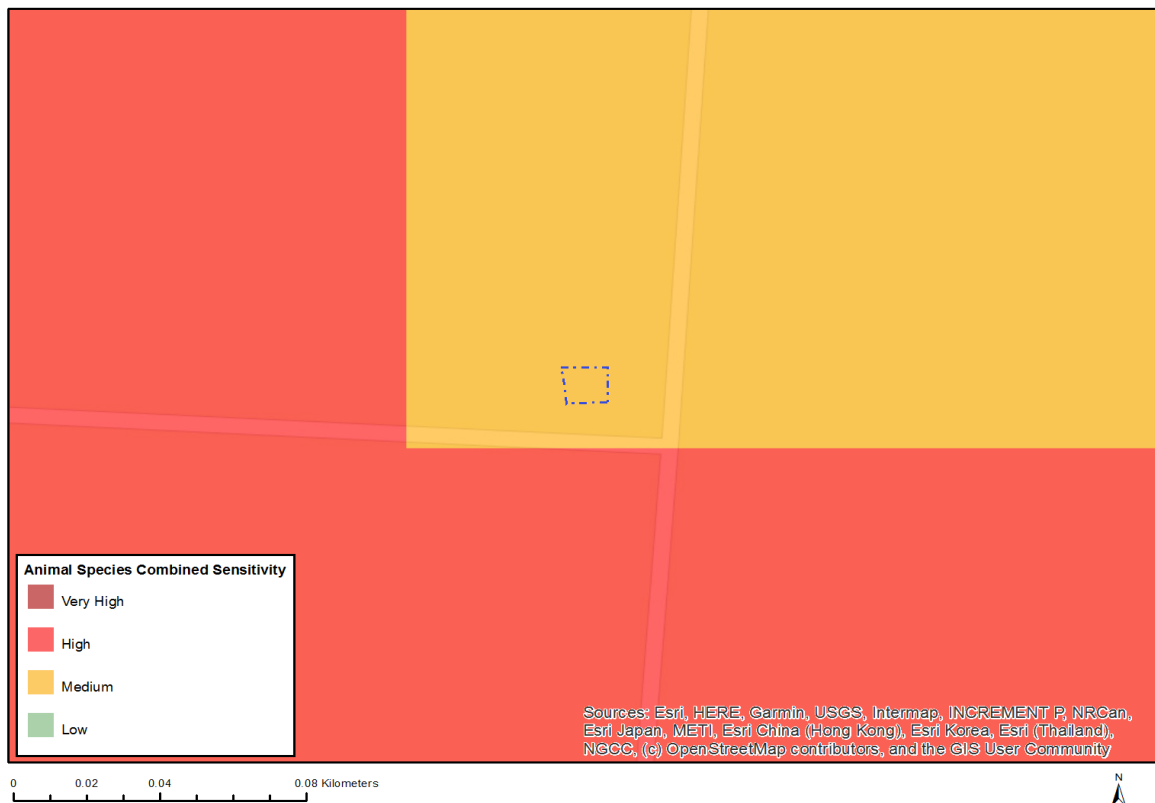

MAP OF RELATIVE ANIMAL SPECIES THEME SENSITIVITY



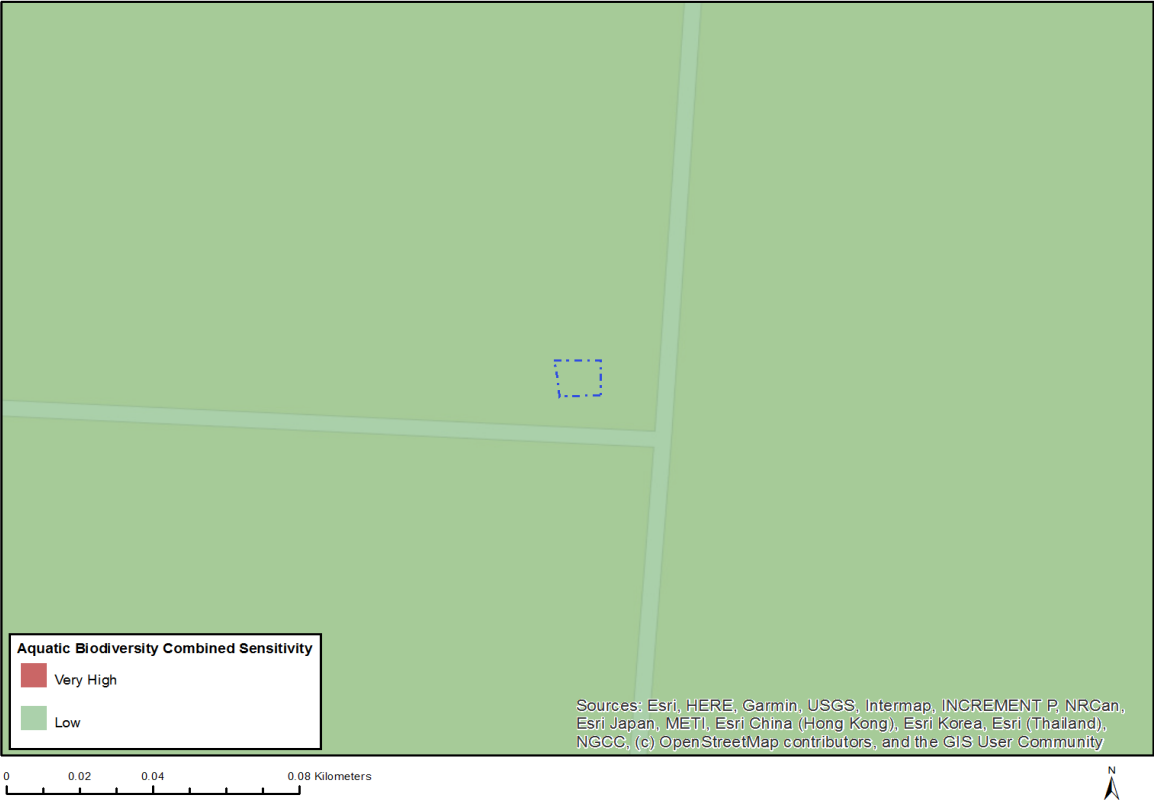

MAP OF RELATIVE ARCHAEOLOGICAL AND CULTURAL HERITAGE THEME SENSITIVITY

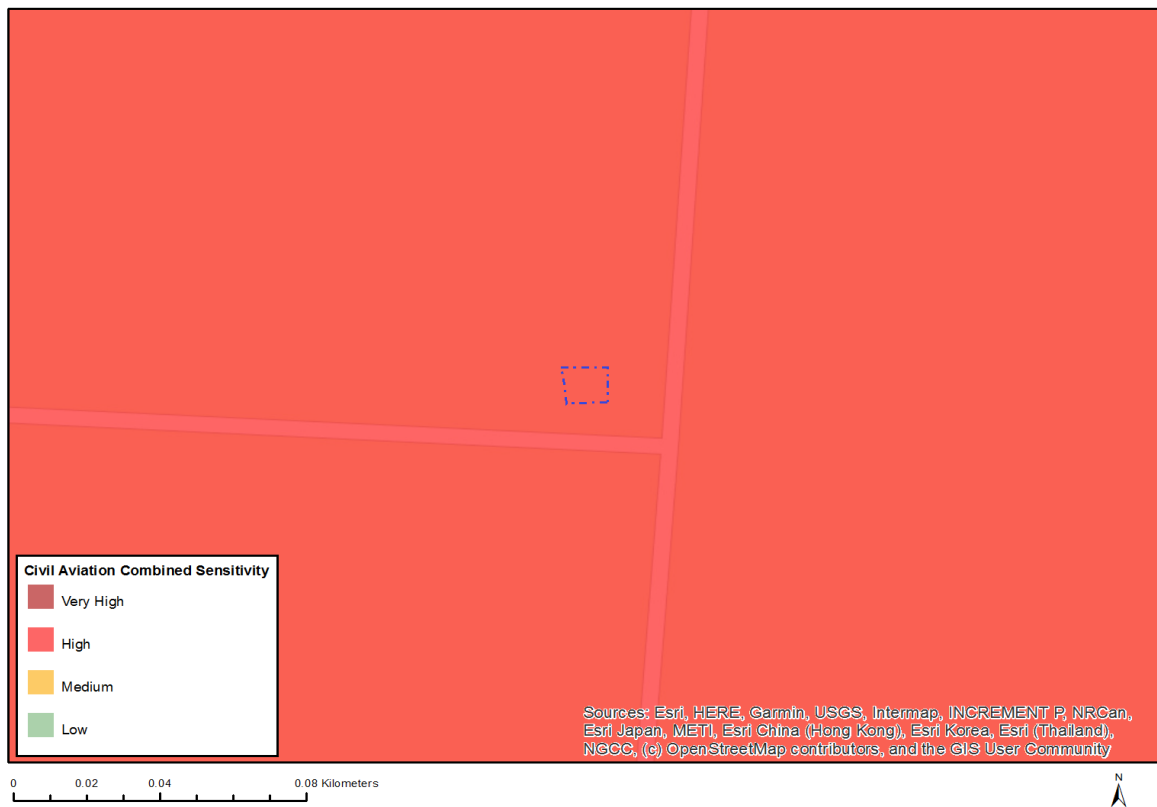
