## 6. Construction Sequence & Methods

To comply with the requirements of the approved rehabilitation plan, the Contractor shall ensure that adequate measures are in place to manage any potential damage caused by the actions of the excavator during the removal of the concrete pipes identified in the rehabilitation plan

- The Contractor shall provide guidance to the excavator operator prior to removal actions
- The existing fence shall be temporarily opened up and access to the pipes directed
- The Contractor shall guide the excavator operator during the removal and lifting process
- The excavator shall not access any other area except the route indicated for entry and exit from the pipes
- The location for the placement of the pipes shall be identified and co-ordinated prior to any initiative taking place
- The excavator track footprints shall be rehabilitated and the fence repaired to the same condition as prior to access

## 7. Quality Processes

- All work to be carried out to the approved rehabilitation plan specifications

## 8. Health & Safety

- All work shall be carried out under safe working conditions

## 9. Environmental

- All personnel (including the excavator operator) shall be required to undergo an environmental awareness induction / training session to inform relevant personnel of their responsibilities towards the environment while involved with the rehabilitation project
- Refuelling of plant will be carried out in accordance with the rehabilitation plan guidelines
- Waste generated during rehabilitation activities shall be managed as per rehabilitation plan guidelines
- Dust generation shall be limited to within acceptable standards
- Provision of a portable toilet for all personnel working on site

## 10. Records

- The daily activity checklist shall be kept for the duration of the contract period
- Photographic monitoring of rehabilitation activities shall be kept for record purposes
