

**Project Description and Location:** A bulk water supply pipeline of approximately 2.5km in length and 350mm in width is proposed on Erven 1886 and 1887, Ceres to supply water to the town of Wolseley. The proposed above-ground pipeline will be on small stilts placed at 4 - 5m intervals and will extend from an abstraction point in the Tierhokskloof Stream to the Witbrug Water Purification Plant, alongside the old water supply pipeline that was constructed in 1953. The existing pipeline will no longer be used when the proposed pipeline becomes operational.

The proposed site is largely located on a mountainside and the co-ordinates along the route thereof include the following:





Photo 1: View of public notice on notice board at offices of Witzenberg Local Municipality

Dear Sir or Madam,

Please be informed that EnviroAfrica has been appointed by the Witzenberg Local Municipality to submit an application for environmental authorisation in order to replace the old water supply pipeline that exists on Erf 1886, Ceres and Erf 1887, Ceres. The old pipeline was constructed in 1953 and is therefore so old that a replacement pipeline is now required.

It was initially thought that the Witzenberg Local Municipality owns both of the aforesaid erven, however, it has recently been learned that Erf 1886 is in fact owned by the National Government of the Republic of South Africa and so the National Department of Public Works is the State Department from which landowner's consent must be obtained before the application for environmental authorisation can be proceeded with.

In light of the above, a draft landowner's consent form has been attached hereto in which it is requested that your Department grant the required landowner's consent to the Witzenberg Local Municipality. You may make any amendments to the draft landowner's consent form that you deem necessary.

In addition, it is hereby confirmed that the National Department of Public Works is an Interested and Affected Party regarding the proposed construction of the proposed water supply pipeline. In light of this, please find attached hereto, documents providing further information on the proposed construction of the water supply pipeline and an invitation to your Department to comment on the matter.

Apologies for the delay in getting back to you.

We have made the following decision: Even though the pipeline does not have a registered servitude, it has been mapped in the Hexriver Complex Protected Area Management Plan (PAMP) – please see attached. We therefore are of the opinion that an amendment to the PAMP will not be required.  
  
However, it is still the responsibility of the applicant (in this case Witzenberg Municipality) to confirm whether they do need to register a servitude for the pipeline as part of a planning process.

Also, FYI I received the following comment from BCGMA:

*"Our interest, would be if the pipeline would affect any water resources, e.g. does it cross a water resource or encroach/affect any wetland? S21c&i water uses have only been introduced since 1998. This means that any NEW development (pipeline or development in or near a watercourse/resource) first needs to obtain a water use authorisation. However, this pipeline had been in existence, so my taking on it, would be that, only if the existing footprint be altered and the route e.g. be changed which affect a water resource, then you would need water use authorisation."*

They would like to see a method statement.

**ACKNOWLEDGEMENT OF RECEIPT AND COMMENT ON THE NOTICE OF INTENT (“NOI”) TO SUBMIT AN APPLICATION FORM FOR ENVIRONMENTAL AUTHORISATION IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO. 107 OF 1998) (“NEMA”) AND THE ENVIRONMENTAL IMPACT ASSESSMENT (“EIA”) REGULATIONS, 2014 (AS AMENDED): THE PROPOSED ESTABLISHMENT OF AN APPROXIMATELY 2.5KM LONG WATER SUPPLY PIPELINE ON ERVEN 1886 AND 1887, WOLSELEY.**

1. The NOI and supporting documentation received by this Department via electronic mail correspondence on 29 November 2022, refers.
2. This serves as an acknowledgement of receipt of the NOI and supporting documentation by this Department.
3. Your attention is drawn to the following Regulations in terms of the EIA Regulations, 2014 (as amended):

Regulation 3(2) states, “For any action contemplated in terms of these Regulations for which a timeframe is prescribed, the period of 15 December to 5 January must be excluded in the reckoning of days.”

Regulation 3(3) states, “Unless justified by exceptional circumstances, as agreed to by the competent authority, the proponent and applicant must refrain from conducting any public participation process during the period of 15 December to 5 January.”

4. It is noted that the duly dated and signed declaration of the applicant and the Environmental Assessment Practitioner have not been included in the NOI. This must be submitted as a matter of urgency.
5. Based on the information provided by you, the proposed development will entail the construction of a pipeline that is 0.35m wide and 2.5km long on Erven 1886 and 1887, Wolseley.
6. **Activity description**
  - 6.1. The NOI indicates that the pipeline will be approximately 2500m long and approximately 0.35m wide. However, the diameter of the pipeline is not stipulated.

- 6.2. The diameter of the pipeline must be included in all subsequent documents submitted to this Department.
- 6.3. Furthermore, the correct development footprint depending on the pipeline diameter also needs to be confirmed.

## 7. Applicable Listed Activities

- 7.1. Activity 19 of Listing Notice 1 of the EIA Regulations, 2014 (as amended) is applied for. However, page 14 of the NOI states that there are no watercourses on or adjacent to the proposed site. The presence of watercourses must be confirmed.
- 7.2. Should watercourses be located on or adjacent to the proposed site, the applicability of Activity 12 of Listing Notice 1 of the EIA Regulations, 2014 (as amended) must be confirmed.
- 7.3. It is noted that Activity 12 of Listing Notice 3 of the EIA Regulations, 2014 (as amended) is being applied for. However, the vegetation occurring (North Hex Sanstone Fynbos) on the proposed site has not been classified as a critically endangered or endangered ecosystem in terms of the National Environmental Management: Biodiversity Act, (Act 10 of 2004) ("NEM:BA"), List of Threatened Ecosystems in Need of Protection.
- 7.4. The applicability of the abovementioned listed activities must be confirmed and a clear motivation must be provided as to how the listed activities are applicable to the proposed development.

## 8. Screening Report

This Directorate notes that the Screening Report (dated 6 November 2022) has identified a number of specialist studies to be conducted. No motivation has been provided as to why certain specialist studies will not be conducted.

## 9. Protocols

- 9.1. The "Procedures for the Assessment and Minimum Criteria for Reporting on Identified Environmental Themes in terms of Sections 24(5)(a) and (h) and 44 of the National Environmental Management Act, 1998, when applying for Environmental Authorisation" ("the Protocols") were published on 20 March 2020 (Government Notice No. 320 as published in Government Gazette No. 43110 on 20 March 2020) and the Protocols are applicable to your proposed development.
- 9.2. According to the Protocols, before commencing with a specialist assessment, the current use of the land and environmental sensitivity of the site under consideration identified by the screening tool must be confirmed by undertaking site sensitivity verification. The outcome of the site sensitivity verification must be recorded in the format of a report.
- 9.3. Be advised that the Protocols must be complied with for every new application that is submitted after 9 May 2020. Specialist studies/compliance statements conducted during the pre-application phase must meet the requirements of the Protocols by the time they are submitted as part of an in-process draft report.
- 9.4. **The Department therefore awaits the submission of the SSV report prior to the commencement of any public participation process.**

## 10. Process

- 10.1. A Basic Assessment process must be followed in order to apply for Environmental Authorisation. Only those activities applied for shall be considered for authorisation. The onus is on the

applicant to ensure that all the applicable listed activities are applied for and assessed as part of the Basic Assessment process.

10.2. You are advised that when undertaking the Basic Assessment process, you must take into account the applicable guidelines including the guidelines developed by the Department. The Department's guidelines can be downloaded from the Department's website (<http://eadp-westerncape.kznsshf.gov.za/your-resource-library>). In particular, the guidelines that may be applicable to the proposed development include, inter alia, the following:

- Guideline for the Review of Specialist Input in the EIA process (June 2005).
- Guideline for Environmental Management Plans (June 2005).
- Guideline on Alternatives (March 2013).
- Guideline on Need and Desirability (March 2013).

10.3. Please ensure the Basic Assessment Report and Environmental Management Programme contains all information requirements outlined in Appendices 1 and 4 respectively of EIA Regulations, 2014 (as amended). Omission of any required information may result in the application for Environmental Authorisation being refused.

11. Page 12 of NOI (point 2.3) indicates that the National Water Act, 1998 (Act No. 36 of 1998) may be applicable to the proposed development. **Confirmation must be obtained from the relevant water authority with respect to the process to be followed and the comment from the water authority must be included in the pre-application Basic Assessment Report.**
12. It is also noted that the proposal triggers Section 38(1) of the National Heritage Resources Act, 1999 (Act No. 25 of 1999) ("NHRA"). A Notice of Intent to Develop ("NID") will be submitted to Heritage Western Cape ("HWC"). **Comment from Heritage Western Cape must be included in the pre-application Basic Assessment Report.**

13. Public Participation Process ("PPP")

- 13.1. A Public Participation Process ("PPP") that meets the requirements of Regulation 41 of the EIA Regulations, 2014 (as amended) must be undertaken.
- 13.2. The BAR must be made available to the Interested and Affected Parties ("I&APs"), including all the relevant State Departments that administer laws relating to a matter affecting the environment, for **comment for a minimum period of 30 days**.
- 13.3. In terms of good environmental practice, you are encouraged to engage with State Departments and other Organs of State early in the pre-application and formal EIA process to solicit their inputs on any of their requirements to be addressed in the pre-application and formal EIA process. Please note that this does not replace the requirement of making the pre-application and formal BAR available to State Departments/Organs of State as stipulated above. The following State Departments, Organs of State and other authorities must be consulted during the pre-application and EIA processes:
  - CapeNature;
  - Heritage Western Cape;
  - DEA&DP;
  - Witzenberg Local Municipality;
  - Cape Winelands District Municipality; and
  - Western Cape Department of Agriculture.
14. Please note that it is an offence in terms of Section 49A(1)(a) of the NEMA for a person to commence with a listed activity unless the Competent Authority has granted an Environmental Authorisation for undertaking it. Failure to comply with the requirements of Section 24F of the NEMA shall result in the matter being referred to the Environmental Compliance and Enforcement Directorate of this Department. A person convicted of an offence in terms of the above is liable to a fine not exceeding

R10 million or to imprisonment for a period not exceeding 10 years, or to both such fine and imprisonment.

## 15. General

- 15.1. Please note that the pre-application consultation is an advisory process and does not pre-empt the outcome of any future application which may be submitted to this Department. No information provided, views expressed and/or comments made by officials during the pre-application consultation should in any way be seen as an indication or confirmation that additional information or documents will not be requested, or of the outcome of an application.
- 15.2. No information provided, views expressed and/or comments made by officials during the pre-application consultation should in any way be seen as an indication or confirmation:
  - that additional information or documents will not be requested; and
  - of the outcome of the application.
