Notice is hereby given of the intention to submit an application for environmental authorisation (EA) and the public participation process thereof, in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The proposed transformation of land to agriculture falls within the ambit of activities listed in terms of the EIA Regulations, 2014 (as amended).

EnviroAfrica cc has been appointed by Silvermoon to undertake the NEMA application process for the EA.

Project Description & Location:
It is proposed that 14 ha of land be cleared and transformed for agriculture on the two adjacent Erven No. 1372 and 1375 in the Boegoeberg settlement, Kenhardt, Northern Cape. Initially short term crops will be planted with the aim to cultivate raisin grapes across the whole site. The proposed site is located approximately 1.75 km northeast of the village Saalskop, Northern Cape.

Area to be transformed to agriculture: 28°44'26.81" S, 21°51'21.20" E.
