Notice is hereby given of the intention to submit an application, and the public participation process in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment (EIA) Regulations, 2014 (as amended). The proposed development consists of a 25 m high Lattice telecommunication mast and associated infrastructure and falls within the ambit of the following activities listed in terms of the EIA Regulations 2014:

Project Description:

EnviroAfrica cc has been appointed by MAST Service (Pty) Ltd to manage the process of applying for Environmental Authorisation for the proposed development of the telecommunication mast and associated infrastructure. The proposed base station will have a total developmental size of approximately 106 m² and will include a 25 m high Lattice Mast. The site will be enclosed by fencing for security reasons.

Property Location:

The proposed development will be located Portion 0 of the Farm No. 1756, Paarl Road, Western Cape, approximately 2,5 km south-east of Wellington.

The site coordinates of the proposed development are 33°40'11.60"S; 19° 1'17.30"E.

Public Participation:

Interested and Affected Parties ("I&APs") are hereby notified of the intention to submit an application for environmental authorisation for the above-mentioned development proposal and are invited to register (in writing) as a stakeholder. In order to register or submit comment, I&APs should refer to the name of the proposed development, and provide their name, address and contact details (indicating your preferred method of receiving notification) and an indication of any direct business, financial, personal, or other interest which they have regarding the application, as per the statutory requirements of the Environmental Impact Assessment (EIA) Regulations (2014, as amended) published in terms of the National Environmental Management Act (Act 107 of 1998) (NEMA). You are also requested to pass this information on to any person that you think should be interested/notified. Comments regarding the proposed development, should be submitted to EnviroAfrica cc on or before **08 October 2024**.

Please note that only **Registered I&APs** will be notified of the availability of reports for public viewing and comment, the outcome of the application, the reasons for the decision and that an appeal may be lodged against the decision.

By registering as an I&AP, you hereby give EnviroAfrica cc the permission to circulate your name and contact details to the relevant stakeholders as stated, per statutory requirements, in line with the


