THE PROPOSED ESTABLISHMENT OF A RENEWABLE PHOTOVOLTAIC ENERGY GENERATION PLANT FOR AN ELECTRIC VEHICLE AND TRUCK RECHARGE FACILITY, NEAR WINTERTON, KWAZULU-NATAL

Notice is hereby given of the intention to submit an application for environmental authorisation (EA) and the public participation process thereof, in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The proposed renewable energy plant for an electric vehicle and truck recharge facility falls within the ambit of activities listed in terms of the EIA Regulations, 2014 (as amended).

Application for EA to undertake the following activities in terms of EIA Regulations 2014:

EnviroAfrica cc has been appointed by Zero Carbon Charge to undertake the NEMA application process for the EA and to facilitate the water applications..

Project Description & Location: It is proposed that a solar photovoltaic (PV) plant, electric vehicle and truck recharge facility, energy storage battery units, overnight parking, stormwater pond, water tanks, lounge area with a kitchen, ablution facilities with a septic tank, shop and offices be developed including associated infrastructure on Portion 11 of the Farm Kop Leegte No. 1154, Registration Division GS. The Solar PV plant will be connected to the electric vehicle and truck recharge facilities via a distribution line with a capacity of approximately 33 kV. The solar PV facility will cover an area of approximately 80 ha. The proposed site is located approximately 15 km east of Winterton, KwaZulu-Natal.

Site co-ordinates (estimated central point): Solar PV facility: 28° 46' 52.168" S, 29° 40' 26.681" E.

<u>Description of Alternatives:</u> Due to the strategic placement required for the renewable electric vehicle and truck charging facilities and other renewable energy developments/proposed developments, alternative sites do not exist. However, alternative options which include inter alia alternative PV technology, layout options and the option of not proceeding with the proposed development at all (the No-Go option) will be considered and assessed in the Environmental Impact Assessment Report (EIR). The EIR will include specialist reports and will undergo a further round of public participation.



Notice is hereby given of the intention to submit an application for Environmental Authorisation (EA) in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended (NEMA), Environmental Impact Assessment (EIA) Regulations 2014, and an application for Water Use Authorisation (WUA) in terms of the National Water Act (Act 36 of 1998) (NWA), as well as the public participation processes thereof. Both applications are for the proposed solar photovoltaic (PV) energy generation plant, the electric truck charging facility, and the associated activities. These activities fall within the ambit of activities listed in terms of the EIA Regulations, 2014 (as amended) and within the ambit of water use activities listed in terms of Section 21 of the NWA.

EnviroAfrica cc has been appointed by N3 Electric Highway Co. to undertake the NEMA application process for the EA and to facilitate the NWA application process for the WUA.

N3 Electric Highway Co. is proposing that a solar photovoltaic (PV) energy generation plant, electric vehicle and truck charging facility, energy storage battery units, overnight parking, stormwater pond, water tanks, lounge area with a kitchen, ablution facilities with a septic tank, shop, offices including associated infrastructure be developed on Portion 11 of the Farm Kop Leegte No. 1154 GS. The solar PV plant will be connected to the electric vehicle and truck charging facility via a distribution line with a capacity of approximately 33 kV. An area of approximately 80 ha will be considered and assessed. The proposed site is located off the N3, at the N3 and Winter/Colenso interchange (207), approximately 15 km east of Winterton, in the uThukela District Municipality, Kwa-Zulu Natal.

Alternative PV technology, layout options and the option of not proceeding with the proposed development will be considered and assessed in the Environmental Impact Assessment Report (EIR).




