Project Description & Location:
 It is proposed that 20 large evaporation ponds be constructed on either Portion 1 or Portion 5 of Farm Uitkyk 889. These will be required for the wastewater by-product of the proposed Kotulo Tsatsi Energy (KTE) hydrogen production facility, proposed on Portion 1 and Portion 5 of Farm Uitkyk 889 (separate application), to be discharged into.

The ponds will have an approximate dimension of 340m length x 115m wide x 2.50m deep each and have a total evaporation area of approximately 80ha in total. The evaporation ponds will be earth embankment structures fitted with multiple barrier HDPE geosynthetic membranes with an integrated leakage detection system.

A number of alternative sites will be considered and assessed. The site will be accessible from the R27 between Kenhardt and Brandvlief via the Soafskolk road and DR2981.
