Hy het 'n groot invloed op baie mense se

lewens gehad. Hy was lief vir die lewe en het dit voluit geleef. Daar is oor die jare menige stories en staaltjies oor hom vertel.

Project Description & Location: The proposed development includes the construction of the Toeka Dam with a storage capacity of 2 000 000m³ and a dam wall height of approximately 14m. It will mainly be supplied with water, being pumped via the proposed ±1 200m pipeline, from the existing Houdenbek-Bo Dam situated in the Houdenbek River, and additionally with water from runoff emanating within the catchment area. The proposed dam will be constructed to store and supply water for irrigation purposes associated with the proposed approximately 80ha agricultural expansion area. The proposed dam footprint/flooded area will cover approximately 40ha of agricultural land on the lower slopes of the Houdenbek Mountains. Approximate site centre point co-ordinates S32°59'35.40"; E19°26'21.20".

Project Description & Location: The proposed development includes the construction of the Harmony Dam with a storage capacity of 250 000m³ and a dam wall height of approximately 13m. It will be mainly supplied with water from runoff emanating within the catchment area. The proposed dam will be constructed to store and supply water for irrigation purposes associated with the proposed approximately 30ha agricultural expansion area. Water will be conveyed via a proposed pipeline from the proposed dam to an existing pipeline. Irrigation pipelines thresholds will not trigger Listed Activities in terms of NEMA and will be located on ploughed land and road reserves. The proposed dam footprint/flooded area will cover approximately 6ha of land on the lower slopes of the Houdenbek Mountains. Approximate site centre point co-ordinates S32°59'47.00"; 19°27'50.00"E.
