THE PROPOSED MAINTENANCE AND CONSTRUCTION OF EROSION PREVENTION INFRASTRUCTURE ON CULVERT C10432 AND BRIDGE 0496, ON DR1489, DE DOORNS.

Notice is hereby given of the intention to submit a NEMA application and the adoption of a Maintenance Management Plan, and the public participation process, in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014, as well as a Water Use License Application in terms of the National Water Act (Act 36 of 1998)(NWA). The proposed maintenance and construction activities includes activities listed in terms of the NEMA EIA Regulations 2014.

EnviroAfrica cc has been appointed by Mariswe (Pty) Ltd, on behalf of the Western Cape: Department of Infrastructure to undertake the NEMA application process for Environmental Authorisation.

Application for environmental authorisation to undertake the following activities*:

Government Notice R327 (Listing Notice 1): Activity No. 12 and 19

Government Notice R324 (Listing Notice 3): Activity No. 14

Application in terms of NWA: Sections 21 c and i*.

**Please note that should the listed activities above change or additional activities be identified during the course of the NEMA application process, registered I&APs will be notified of any changes.*

Project Description & Location: The proposed maintenance and construction work includes the following:
Culvert C10432: Remove approximately 20m3 of accumulated material from culvert inlet and culvert chambers and install a gabion basket of approximately 10m3 in size to extend existing retaining wall in an upstream direction for further erosion protection of outer stream bank at the culvert.
Bridge 0496: Install a gabion basket of approximately 8m3 in size to protect the Pier 1 footing of the bridge from further erosion.

The culvert and bridge are located along DR1489, approximately 4km west of De Doorns, Western Cape.

Approximate centre-point site co-ordinates:
Culvert C10432: 33°28'41.29"S, 19°37'06.22"E. **Bridge 0496:** 33°28'56.58"S, 19°37'16.69"E

Public Participation: Interested and Affected Parties (I&APs) are hereby notified of the applications and invited to register (in writing) and/or provide initial comments and identify any issues, concerns or opportunities relating to either, or all of, the projects to the contact details provided below, **on or before 04 March 2026** in terms of the environmental aspects (NEMA Application) and **on or before 08 April 2026** for water related issues (NWA application). In order to register or submit comment, I&APs should refer to the project name/s, and provide their name, address & contact details (indicating your preferred method of notification) and an indication of any direct business, financial, personal, or other interest which they have in the application. You are also requested to pass this information to any person you feel should be notified.

Please note that only Registered I&APs will be notified of the availability of reports and other written submissions made (or to be made) to the Department by the applicant, and be entitled to comment on these reports and submissions; will be notified of the outcome of the application, the reasons for the decision, and that an appeal may be lodged against a decision; and will be notified of the applicant's intention to appeal the decision, and where and for what period the appeal submission will be available for inspection.
