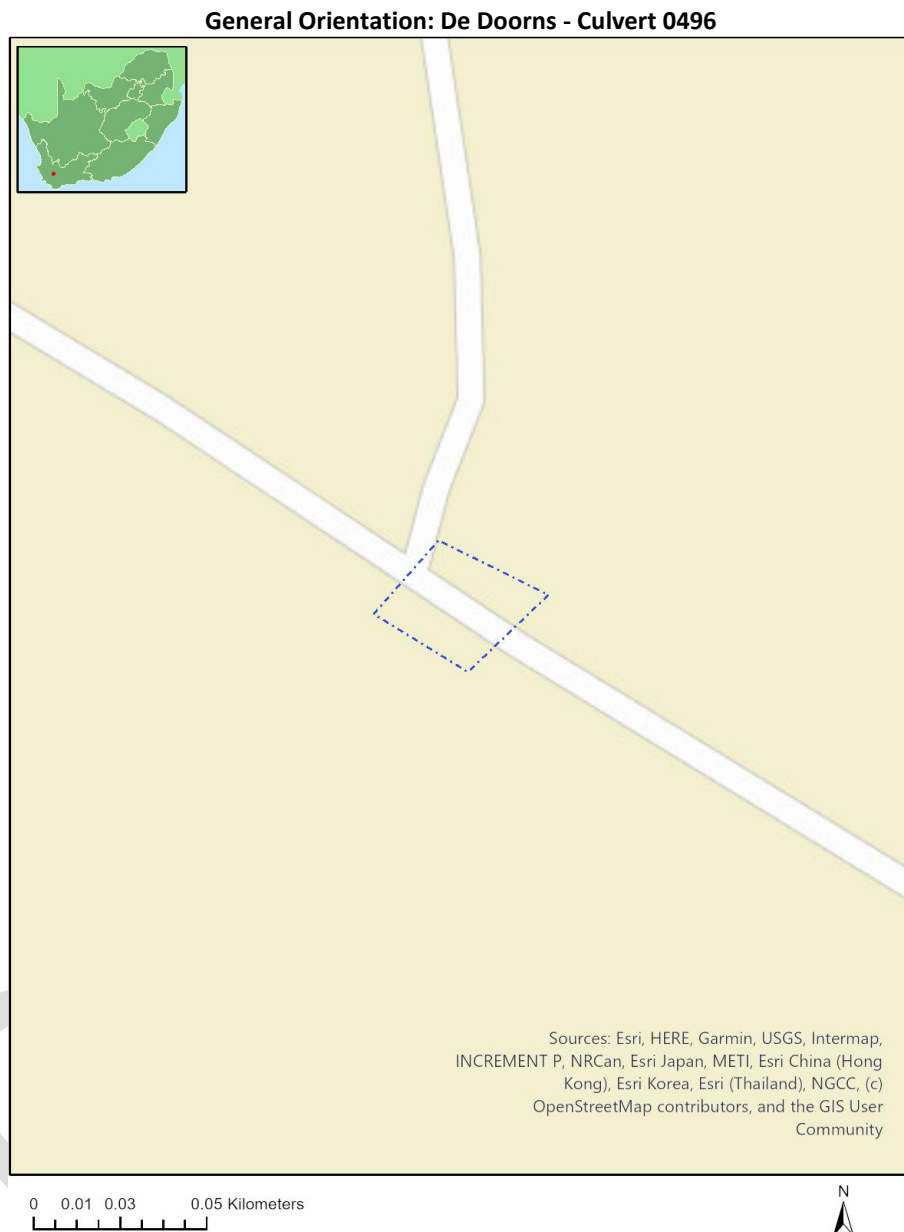

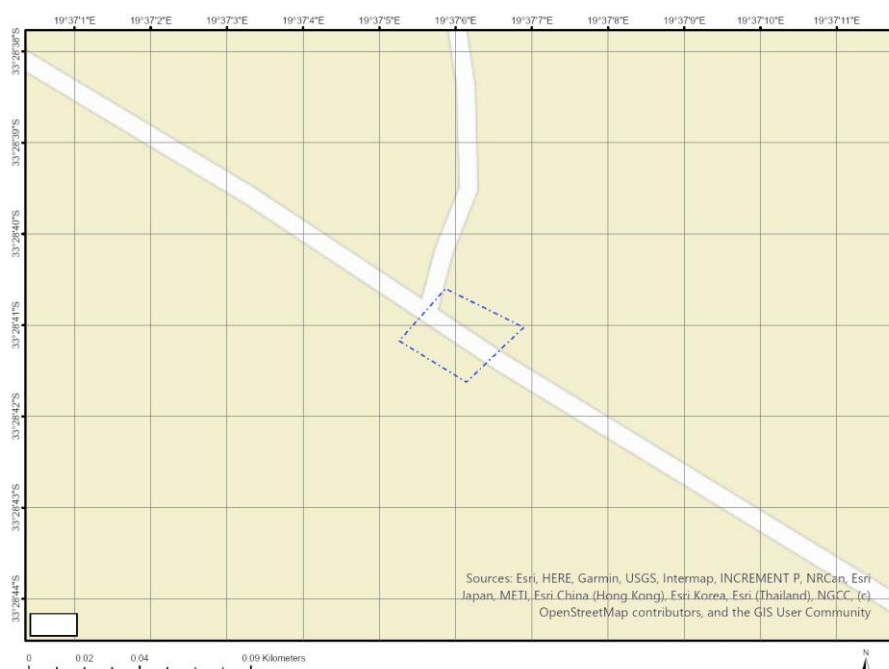

MAP OF RELATIVE DEFENCE THEME SENSITIVITY

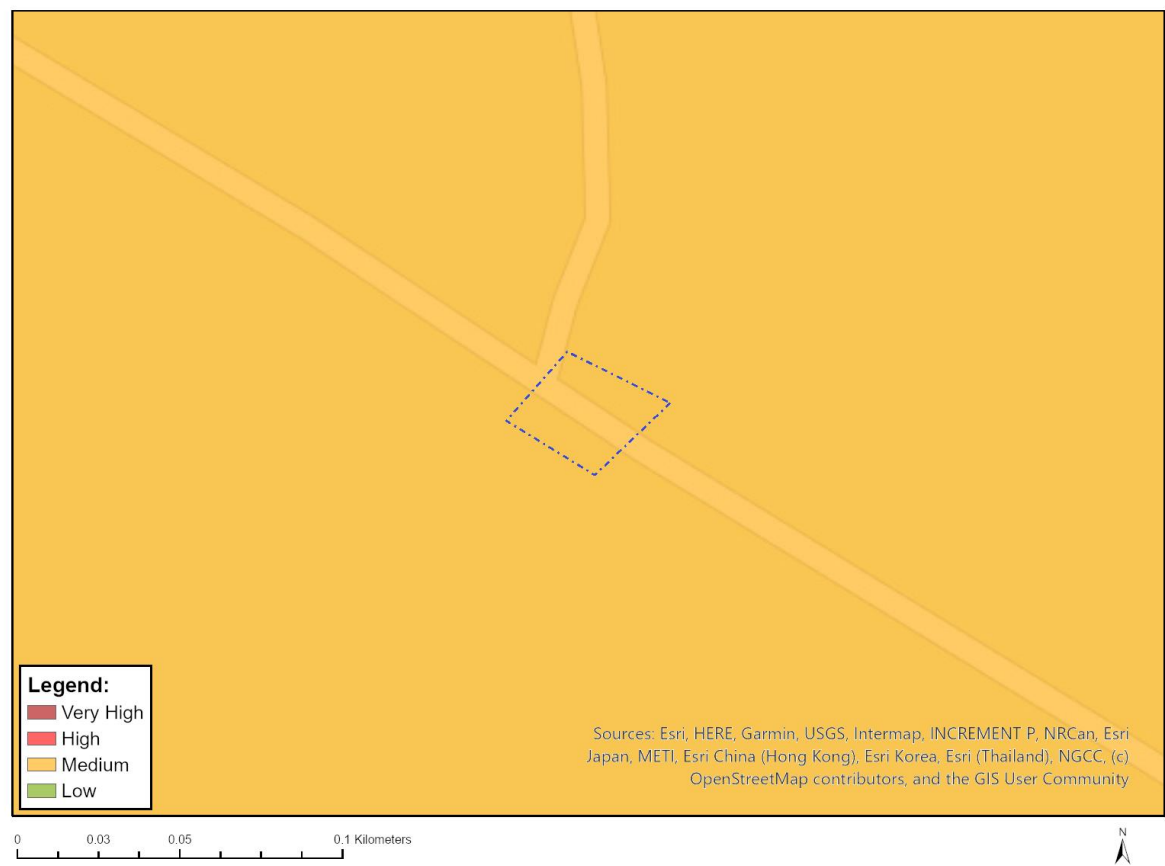

MAP OF RELATIVE PLANT SPECIES THEME SENSITIVITY



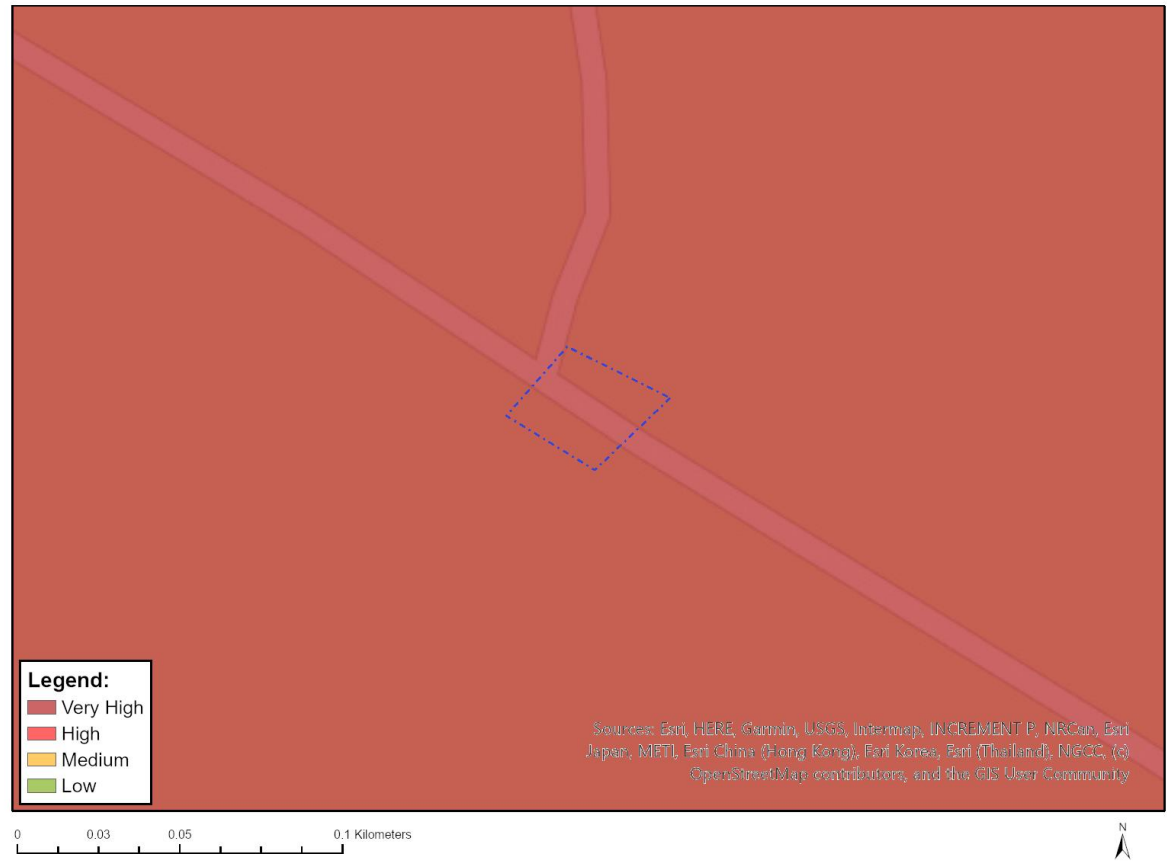
